

## ORDER

No. 2479

/MA Dated:- 07-05-2021

Whereas considering the unprecedented surge in COVID-19 cases across the State, the Government of Haryana has considered it necessary to take effective measures to prevent its spread in the State of Haryana and declared lockdown from 03.05.2021 (05.00 AM onwards) to 10.05.2021 (till 05.00 AM) in the State of Haryana vide order No. DMC-SPO-2020/5215 dated 02.05.2021;

AND whereas, the District Administration, Sirsa has issued schedule for opening of shops/establishments dealing with essential commodities/services, so as to avoid inconvenience to citizens. However, the possibility of hoarding/black marketing of essential commodities/equipments/devices cannot be ruled out. In order to ensure prevention of hoarding, black marketing and profiteering of essential items/equipments/services sold/rendered by pharmacists/chemists/diagnostic shops/grocery shops/fruit & vegetable shops-vendors, the provisions of Essential Commodities Act, 1995 as well as order issued by National Pharmaceutical Pricing Authority (NPPA), Govt. of India must be complied with.

Hence, in view of the said regulations, following committees of the officers and civilians/volunteers are hereby constituted to ensure that there is no hoarding, black marketing and profiteering of essential items/equipments/medicines/services in Sirsa City:-
