As such, provisional selection of the said candidate is cancelled & the candidate figuring at Waiting list Sr. No. 01 as per the merit namely Shaista Akram D/o Mohd Akram Thoker R/o Marhama Panchpora Anantnag is provisionally selected for the post of Staff Nurse under NHM in Block Bijbehara, District Anantnag

Whereas, DRHS Anantnag issued Provisional Selection list for various categories of posts under NHM in District Anantnag vide Notification No. CMO/DRHS/NRHM/20-21/1446-51 dated:- 15/10/2020, wherein one candidate namely Mehpara Samad D/o Ab Samad Naikoo R/o Nagam, Anantnag was provisionally selected for the post of Staff Nurse under NHM (LaQshya) in Block Larnoo, District Anantnag. Said candidate submitted an Application along-with Affidavit duly attested by the Judicial Magistrate to this office mentioning therein that she is not interested to join for the said post and as such her Provisional Selection for the post of Staff Nurse may be cancelled. Whereas, DRHS Anantnag issued Provisional selection list for various categories of posts under NHM in District Anantnag vide Notification No. CMO/DRHS/NRHM/20-21/988-93 dated:- 03/09/2020, wherein one candidate namely Uzma Padder D/o Mohd Ayoub Padder R/o Bona Dialgam, Anantnag was provisionally selected for the post of Staff Nurse under NUHM, NHM in Block Achabal, District Anantnag and said candidate resigned from the Post of Staff Nurse within less than 01 (One) month. Accordingly, candidate figuring at Waiting list Sr. No. 01 as per the merit namely Asifa Yousuf W/o Mudasir Rajab Dar R/o Brakapora Anantnag is provisionally selected for the post of Staff Nurse under NUHM, NHM in Block Achabal.
