



**NOTICE INVITING APPLICATIONS FOR PITCHING BOARDING TENTS/ SHOP-TENTS
ENROUTE PAHALGAM ROUTE FOR SANJY-2021**

1. Applications (online/offline) on prescribed form (**in duplicate**) are invited from individuals/agencies for grant of permission to pitch boarding-tent/shop-tents at various Yatra Camp sites via Pahalgam route, i.e **NUNWAN/SHESHNAG/PANJTARNI & HOLY CAVE** for Yatra, 2021.
2. For manual mode, the application forms shall be available from **15th February, 2021 to 15th March, 2021** in the **office of the Chief Executive Officer, PDA, Pahalgam**. The intending tent/shop owners will be required to submit **filled-in Application Forms from 01-03-2021 to 31-03-2021** in the **office of the Chief Executive Officer, PDA Pahalgam**.
3. **In case of online mode, the applicant shall visit the link (sanjayang.in) to submit the application form, within the time window of 01.03.2021 to 31.03.2021.**
4. **The intending shop/tent owner must clearly indicate his/her preference to pitch boarding tent/shop tent for various Camp locations in the Application Form, in case he intends to apply for more than one location.**
5. The applicants shall be required to manage/pitch the tent/shop himself/herself and that no subletting/proxy shall be permissible. In case any such complaint/report comes to the notice, the permission granted shall be deemed to have been cancelled ab-intio.
6. The applicants may note that they shall have to submit a character certificate before the competent authority before permission is issued for pitching Tents/Shops in SANJY-2021.
7. The Shops/Tents Permission shall be granted **through draw of lots**.
8. The Shop/Tent Permission holder will be require & to pitch tent of the following specifications:
 - a) ***12'x14' for boarding tents.***
 - b) ***8'x12' for shop tents.***

Specifications:

- a) ***Double-Fly untorn canvas or cotton tent.***
 - b) ***Inner Fly-100% waterproof canvas or cotton of at least 500 GSM with lining.***
 - c) ***Outer Fly-100% waterproof canvas or cotton.***
 - d) ***Canvas or cotton should be rat proof and fire retardant.***
 - e) ***With ground sheet (water proof) complete with metal/wooden poles and pegs.***
 - f) ***Weather hoods on both sides for protection against rain/snow.***
9. No individual/family shall be issued permission to pitch more than two tents in the Yatra area.
 10. Only one person (Permission Holder) who will be issued Identity Card shall be allowed to enter the Yatra area for managing the tent.
 11. No application form shall be entertained after the prescribed date.
 12. The tents after the permission is granted, shall be pitched at locations as shall be assigned by the competent authority during draw of lots.
 13. Permission will be issued to the eligible applicant if he agrees to abide by the prescribed terms & conditions.
 14. All the allottees shall be liable to follow SOPs pertaining to Covid-19 or any other guidelines issued from time to time.
