The Tender cost fee and the EMD amount should be submitted separately in shape of demand drafts in the technical bid. In case of any bid amendment and clarification, responsibility lies with the bidders to collect the same from the website or the office notice board before last date of purchase of tender document and the C.D.M.O shall have no responsibility for any delay / omission on part of the bidder.

3. A pre bid meeting will be held on dtd. **11 -02-2020 at 11.00 A.M** at O/O CDM & PHO, Koraput with interested bidders in presence of the committee members.
4. Violating the tender terms & conditions & non supply/partly supply which is not as per the technical specification will be declared blacklisting and disqualify the firm for participations.
5. Tender document should be type written or computerized falling which the bidders will be in eligible for consideration. No further correction will be allowed.

**The cover” B Price Bid should contain as follows(Section II)**

1. Financial Bid must be submitted in the prescribed format as attached in Section II. No other document cost should be enclosed in the Financial Bid. The Financial Bid should be sent in a separate sealed cover called Cover B Price Bid
2. The rate should be computerized.
3. If there is difference in Figures & Words, words will be taken in to consideration

## Eligibility Criteria

Sealed tenders are invited from the eligible bidders as per the eligibility criteria for supply of Bike Ambulance under Special Assistance.

1. The Bidders have to submit their tenders in separate sealed cover Cover "A" Technical Bid & Cover "B" price Bid. Both the covers should be put into a third cover "C" which must be superscribed as Tender for supply of Bike Ambulance.
2. The Cover A " Technical Bid) should contain as follows
  - a) Checklist with details of the documents enclosed in Cover A"(As per **Annexure-I**) with page number. The document should serially arranged as per this annexure-I and should be securely tied and bound.
  - b) Tender document cost Rs.1000 plus 18% GST( One thousand One hundred Eighty only) non refundable in shape of Bank Draft in favor of CDM & PHO, Koraput.
  - c) EMD of Rs.20,000.00( Rupees Twenty Thousand only) refundable in shape of CDM & PHO, Koraput
  - d) Items with specification quoted individually in the prescribed format (**Annexure II**),if any deviation of specification that should be clearly mentioned which shall be acceptable if it is found the latest version of Royal Enfield.
  - e) Copy of the valid manufacturing license in case of the manufacturer/import license in case of importer/authorized license in case of authorized distributor as the case may be.(**Annexure III**)
  - f) Copies of the Organization PAN.
  - g) IT return of last FY 2018-19 with audited statement of current year.
  - h) Annual Turn over certificate of the last three years(2016-17,2017-18,2018-19) duly signed by Chartered Accountant. (**Annexure-IV**)
  - i) Photocopy of GST registration certificate.
  - j) Manufacturing unit/supplier who has been black listed either by the tender inviting authority or by any state govt. or central govt. organization is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration by a Notary Public.(**Annexure-V**)
  - k) Leaflet or Technical Broacher of the product/items offered.
  - l) They should quote the rate inclusive of excise duty, insurance(5 years comprehensive plan),packing forwarding, freight(door delivery and exclusive of GST if any for complete structure of bike ambulance and should submit self declaration
  - m) They must submit the agreement paper, warranty document, &undertaking that they will supply with in 30 days after issue of purchase order. In case non supply, the authority may allow extension for a maximum of 02 weeks after the stipulated period with a penalty of 05% per week which will be deducted from the purchaser order value as liquidated damage. (**Annexure-VI & VII**).
  - n) Price should be quoted with on road price i.e. cost of vehicle ,insurance, GST registration with RTO and accessories if any with proper money receipt
  - o) All the tender document should sign by the bidders at the bottom of each page with official seal affixed.
  - p) Any dispute arises will be resolved in Koraput jurisdiction.
