## TERMS AND CONDITIONS

1. As per Works Department Memo No.17254,, dated, 05.12.2017 only those bidders who successfully remit electronically **Cost of Tender Paper and Earnest Money Deposit on submission of bids would be eligible to participate** in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure. ***(Detail of procedure & settlement of EMD & Cost of tender paper is enclosed in DTCN).***
2. Other details can be seen from the Bidding documents which is available in Website [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in)
3. **Engineer contractors who want to avail EMD exemption** have to **submit one affidavit** with tender declaring therein to the effect that they have not yet availed **3** (three) nos of EMD exemption during the financial year **2018-19** and to show the original Registration Certificate to the tender opening authority for confirmation at the time of opening.
4. Additional Performance Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid prior/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus then the quoted amount as Additional Performance Security in shape of Post Office Savings Bank Account/ National Savings Certificate/Post Office Time Deposit Account/ Kissan Vikash Patra/ Deposit Receipt of Schedule Bank Term Deposit Receipt pledged in favour of the Divisional Officer at the time of drawal of agreement. The bids of the technically qualified bidders will be opened for evaluation of the price bid. The successful bidders quoting less bid price/rate than the estimated cost put to tender and have not furnished the exact amount of differential cost (i.e estimated cost put to tender minus the quoted amount) as Additional Performance Security in shape of Term Deposit Receipt.
5. The Bid documents should be up-loaded by the Bidders on-line in [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) accompanying the Registration certificate, G.S.T.N.Certificate, PAN card as per Annexure-A attached in the DTCN No relation certificate , affidavit about the authenticity of the tender documents as well as EMD exemption shall have to be deposited before the Tender Opening Authority during office hour from **dt.21.06.2018 to 28.06.2018** or by Regd.post/Speed post to Executive Engineer, M.I.Division, Sambalpur. 6. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals upto two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through transparent lottery system, where all bidder/ their authorized representatives, the concerned Executive Engineer and DAO will remain present as per Memorandum 12366 dated,08.11.2013 of Works Department , Govt. of Odisha and Office Memo No.10224, dt.01.09.2015 of Works Department, Govt. of Odisha.
7. The date of lottery scheduled to be held on **dt.03.07.2018**. The bidders/Authorised agents of bidders should remain present at the time of conducting transparent lottery.
8. After opening of the bid, the original documents as per requirement of the DTCN will be verified by the tender opening authority within **03**(three) working days of opening of the bid.
9. Bid for the work shall remain open for acceptance for a period of Ninety days from the last date of receipt of Bids. If any Bidder / Tenderer withdraw his Bid / tender before the said period or makes any modifications in terms and conditions of the Bid, the said earnest money shall stand forfeited.
10. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for a period of two years after his retirement from Government Service without Government permission.
