Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.
3. The Bid documents will be available in the website www.tendersodisha.gov.in from 12:00Hours of 30.06.2018 to 17:00 Hours of 16.07.2018.
4. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
5. Bids shall be received only "On-line" on or before 17:00 Hours of 16.07.2018.

6. Bids received "on-line" shall be opened at **11:30 Hours on 18.07.2018** in the office of the **District Project Coordinator SSA, Sambalpur**, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. Original Bid Security & demand draft towards cost of bid document and other documents mentioned in detail tender call notice shall be submitted in the office of the undersigned on or before **11:00 Hours** on dated. **18.07.2018** during office hours on working days failing which the bid will be rejected. The original bid security and cost of bid document in a sealed cover will be dropped in the tender box kept in the office of the undersigned for the purpose, which will be opened at **11:30 Hours** on **18.07.2018**. **Non-submission of original bid security and demand draft towards cost of bid document within the designated period shall debar the bidder from participating in the online bidding system and his name also shall be informed to the registering authority for cancellation of his registration.**
8. The cost of bid documents has to be paid by each bidder in shape of demand draft drawn in favour of the **District Project Coordinator , SSA, Sambalpur** from any nationalized scheduled bank payable at **Sambalpur** towards cost of tender paper including GST.
9. **Original Bid Security & Demand draft** towards cost of bid document may be submitted in the Office of the undersigned in favour of **District Project Coordinator, SSA, Sambalpur** on or before **11:00 Hours** on dated **18.07.2018** during office hours on days failing which the bid will be rejected..
10. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
11. Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit in original to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.

13. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding".
14. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely **withdraw** from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
15. Any corrigendum / Addendum will be displayed in the website **www.tendersodisha.gov.in** only.
