GENERAL INFORMATION

1. The vehicle put to tender will be disposed off on the bases of "as where is "condition along with outstanding tax liabilities if any.
2. The intending bidders may inspect the vehicle with permission of concerned authority, premises at different institution.
3. The intending bidders shall have to deposit Rs. 1000/- (Rupees one thousand) only as earnest money in shape of bank Draft in any nationalized bank infavour of Chief District Medical & Public Health Officer, Sambalpur separately for each vehicle along with tender. Tender without Earnest Money deposit will not be considered.
4. The earnest money deposited by the un-successful bidders will be refunded to them on the day of opening of tender paper (within one week).
5. The bidders quoting highest price or above the price fixed by the Authority shall deposit 25% of the offered amount with the Chief District Medical & Public Health Officer, Sambalpur immediately on confirmation of the acceptance of the tender by the Chief District Medical & Public Health Officer, Sambalpur in shape of demand Draft payable to Chief District Medical & Public Health Officer, Sambalpur and the rest amount within 7 days, on failure of the make payment of the amount as aforesaid, the vehicle including the earnest money shall be forfeited and the vehicle will be put to fresh.
6. The vehicle will be handed over to the successful bidder after making full payment of the accepted tender money.
7. The tools and spare parts etc. shall not be delivered along with the vehicle.
8. Photo copy of ID Proof and Pan Card of the bidders should be furnished along with the tender paper.
9. The bidders shall remove the vehicle from the site within 07 days for the payment of the money. Beyond the said period safe guard of the vehicle shall be the responsibility of the bidder and no claim or complain on that accounts shall be entertained.
10. On the failure to remove the vehicle within stipulated time ground rent @1% of the tendered money shall be charged each day or part of day till the vehicle is removed from the site.
11. Where the ground rent so charges exceed the sale price deposited then the right on the vehicle will be ceased.

12. The price offered by the bidder even though highest, but lower than the off-set price fixed will be rejected.
13. The Chief District Medical & Public Health Officer, Sambalpur in charge of the above vehicle reserve the right of rejecting any of the tenders without assigning any reason thereof.
