SEALED TENDER NOTICE

Sealed tenders in plain paper are invited by the undersigned from the intending bidders from date 20.08.2018 for auction sale of the office vehicle (MAHINDRA & MAHINDRA JEEP) bearing Registration No. OR-15-B-4042 on "as is where is basis". The offset price of the vehicle has been fixed at Rs. 30,000.00 (Rupees thirty thousand) only. The intending bidders may inspect the vehicle in the office campus of the undersigned located at Tahasil Office, Rengali on any working day during office hours. The intending bidders may submit their sealed tenders in the drop box available at Tahasil Office, Rengali which should accompany Earnest Money Deposit of Rs. 3000.00 (Rupees three thousand) only in shape of Bank Draft in favour of the Tahasildar, Rengali payable at SBI, Rengali, Sambalpur (Registered Post/Speed Post/ Ordinary Post/Courier Post etc. shall not be entertained). The earnest money of the unsuccessful bidders shall be returned to them soon after the acceptance of the highest offer. The last date for receipt of sealed tenders is fixed on 3rd September, 2018 by 1.00 P.M. and the tenders so received shall be opened on same day at 3.00 P.M. in presence of the bidders/their authorized agents, if any. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof. This tender is subject to the terms and conditions as annexed vide Annexure-I.

TERMS AND CONDITIONS

1. After the acceptance of the highest bid, the highest bidders whose tender will be accepted shall have to deposit 25% of the accepted highest bid amount immediately on the spot and the rest 75% within 07(seven)days from the date of receipt of the ratification/confirmation of the price. Highest bid below the approved upset price shall have to be referred to the competent authority.
2. In case the highest bidder fails to make the deposit in full as per the terms of the notice within the stipulated time, the deposit already made alongwith EMD shall be forfeited to government without making any correspondence to the person concerned and the vehicle will be put to fresh auction sale. The amount deposited in shape of EMD at the time of acceptance of the tender shall be subject to adjustment at the time of final payment.
3. The vehicles shall not be delivered to the highest bidder till full payment is made and other formalities are complied with. No tools, equipments or spare parts will be delivered.
4. The highest bidder is liable to pay MV tax, if any outstanding against the vehicles as well as GST as applicable will be charged extra on the bidding amount.
5. The highest bidder shall remove the vehicles from the office campus of the undersigned within 03(Three) days from the date of full payment of highest bid amount failing which no claim/complaint of any sort shall be entertained in this regard. The highest bidder shall be responsible for safe custody of the vehicle after the aforesaid period.
6. The highest bidder shall be charged ground rent of 1 % of the tender amount per day or part of the day, if he fails to remove vehicle within the stipulated period from the site.
7. Where the ground rent exceeds the highest bid amount (sale price) deposit, the highest bidder ceases to have any right on the vehicles. The sale price deposited will be adjusted towards ground rent and the vehicle will become the absolute property of govt. and will be deposited off by fresh tender sale.
