**TERM AND CONDITIONS FOR RUNNING OF TWO, THREE & FOUR WHEELERS
STAND AT THE VSS INSTITUTE OF MEDICAL SCIENCES & RESEARCH, BURLA
CAMPUS, BURLA (SAMBALPUR)**

Whereas the work to run the Bicycle, Two, Three and Four Wheelers stand round the clock inside the campus areas in VSS Institute of Medical Sciences & Research, Burla Dist: Sambalpur offered to execute the above work for twelve Months from the date of signing of the agreement.

1. The rates for collection of fee for parking of vehicle will be as follows.

(i) Bicycle	...	Rs. 2/- (Rupees Two)
(ii) Other Two Wheeler	...	Rs. 5/- (Rupees five)
(iii) Three Wheeler	...	Rs. 20/- (Rupees Twenty)
(iv) Four Wheeler	...	Rs. 50/- (Rupees Fifty)

2. The tenders are required to submit EMD of **Rs. 2,000/-** (Rupees Two thousand) only in shape of Bank Draft from a Nationalized Bank duly pledged in favour of the Superintendent, VSS Institute of Medical Sciences & Research, Burla. The minimum Bid amount of tender is Rs 1,90,000/- per year. No tender will be accepted less than the Bid amount i.e. Rs 1,90,000/- The highest bidder will be selected for the above work & the tender are required to enclose the following documents in the tender.
 - a. Photo copy (attested) of PAN Card.
 - b. Photo copy (attested) of Adhar card & Voter card.
 - c. Original red money receipt / Bank Draft towards cost of Tender Paper.

3. The selected tender will deposit the Bid amount in one installment & Rs 1,00,000/- (Rupees One Lakh) only as security deposit after finalization of the tender in the Users Fee counters of this Hospital immediately on receipt of order within a week. The security money will be refunded after completion of tender period.



4. **The Specified Area for parking are as follows:**
 - a. **One specified area in front of the OPD Building and another side of Netaji Chowk gate to PG Chowk gate.**
 - b. **One in between the OPD and IPD Building Road behind the Hospital.**
 - c. **Other specified area will be intimated before execution of tender.**

5. The party will keep the Bicycle, two, three and four wheelers of the Student and Staff free of cost in the specified area i.e. in front of the IPD Building back side of the police out post.

6. The party will be responsible for any with theft of the Bicycle, Two, three and Four Wheelers vehicles and in case of any theft the cost will be borne by him after evaluation of the prices by the undersigned.

7. In case of any dispute arising between the parties, the case be filed only within the jurisdiction of Sambalpur in the State of Odisha.

8. No. shop or any kind of Tea / Betel shop will be allowed to run inside the stand area/hospital campus.

9. Any matter not covered in the agreement will be mutually settled by the parties. In case of disputes between the parties the decision of the Chairman, SBS, VSS Medical College Hospital, Burla will be final and binding on both the parties.

10. Any negligence or lapse on the part of 2nd party to run the stand regularly to the satisfaction of the first party the 2nd party shall be liable for termination of this agreement. Before termination of the agreement, 7(seven) days show cause notice shall be issued to the 2nd party.


11. The selected party should deposit the bid amount in the User's fund of VSS Medical College Hospital, Burla. In case of cancellation of tender the bid amount will be returned as per calculation of actual days of operation of the stand.

12. The 2nd party will provide uniforms and identity Card to their employee.

13. The last date for receive of tender is 12-11-2018..... up to 5 P.M..... which will be opened on the next working day at 11.00 AM.

14. He will deposit the total amount months deposit.
