TERMS AND CONDITIONS OF THE TENDER CALL NOTICE

1. Sealed Tenders for purchases of condemned articles are invited by the undersigned from the interested Regd. Firms registered under the GST Act for purchase of the condemned materials from this Hospital so as to reach in the office of the Superintendent, VSS IMSAR, Burla on or before _____ up to 5.00PM and will be opened at 11.00PM on the next working day.
2. The tender can be obtained from the office of the Superintendent, VIMSAR, Burla on all working days and hours from the date of publication of the tender to the last date of submission of tender on payment of Rs.1000/- (Rupees one thousand) only at the User charges counter.
3. The tender can also be downloaded the tender from the dist website www.sambalpur.nic.in and submit the tender with a bank draft or Rs.1000/- (Rupees one thousand) only payable at State Bank of India, Burla Branch.
4. The tenders received after the due date and time will not be entertained.
5. The condemned materials to be sold by the VIMSAR, Burla are as follows:
 - (a) Shredded Plastic Saline bottles and Plastics
 - (b) Iron Scrapes
 - (c) Aluminum Scrapes
 - (d) Stainless Steel Scrapes
 - (e) Broken Glass
 - (f) Wooden Scrapes
 - (g) Brass Scrapes
 - (h) Wooden Planks
 - (i) Tin Scrapes
 - (j) Electronics Wastes.
6. The tenderer may like to see the materials which are preserved in the stores of this Hospital during the office hours on working days before quoting their rates.
7. The above materials will be sold to the highest bidder on cash payment.
8. The rates should be quoted per Kg against each item.
9. The cover of tender must be sealed and superscribed as **"TENDER FOR PURCHASE OF CONDEMNED MATERILS"** from VIMSAR, Burla.
10. The tenders has to deposit a sum of Rs.10,000/- (Rupees ten thousand) only as EMD in shape of Bank Daft duly pledged in favour of Superintendent, VSS Institute of Medial Science and Research, Burla.
11. The Tenderer has to submit the following documents in their tender.
 - (a) Photostat copies of Income tax return of their firm.
 - (b) Photostat copy of PAN Card or Voter ID.
 - (c) Photostat copy of GST registration certificate.
 - (d) Money receipt/BD of 1000/- (Rupees one thousand) only
 - (e) EMD pf Rs.10,000/- (Rupees ten thousand) only inshape of Bank Draft.

12. The selected firm has to lift the materials within 07 (seven) days from the order failing which their EMD will be forfeited and work order will be issued to the next highest Bidder.
13. The tenderer has to quote rates for all the items and to lift all the items compulsorily failing which their tender will be cancelled.
