



Quotation Call Notice No. 332 Date 03.07.2019

Sealed quotations are invited from interested reputed Travel Agencies / Tour Operators or Pvt. individuals for providing one number of Diesel Driven Vehicle (preferable One Bolero) having sitting capacity not more than ten including driver, which shall conform to the Terms & Conditions noted below for official use in Special Land Acquisition Section, Sambalpur on monthly rent basis.

1. The Vehicle must be in Road Worthy condition, shall not be more than 3 (three) years old from the date of initial of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc, which are mandatory for playing of Vehicle, However, the undersigned may prefer the newer Vehicle if otherwise eligible.
2. The Driver of the Vehicle must have a valid Driving License for driving light transport passenger Vehicle and should be sufficiently experienced in driving transport passenger Vehicle.
3. The Driver should be well behaved, gentle and obedient in nature. The undersigned will be at liberty to disengage the Vehicle if the behavior of the driver found unsatisfactory.
4. The monthly rate of hire charge to be quoted separately in the general bid information (excluding fuel and lubricants). The maximum monthly hiring charge of the Vehicle (excluding fuel and lubricants) is Rs.20,000.00 (Rupees Twenty Thousand) only as per the instruction issued by the Finance Department, Govt. of Odisha vide office Memorandum No.27037/F Dated 08.10.2015.
5. The Vehicle must achieve a fuel efficiency of 10 KMs per liter.
6. The details of the make and year of manufacture of the Vehicle, Registration No, Mileage (KMs covered per liter) and name of the driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation (annexure-I).
7. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the Vehicle / bidder.
8. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
9. In case of emergency, the driver and vehicle will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
10. Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per the possible within 15 (fifteen) days of submission of bills by the service provider subject to availability of fund and no advance payment will be made.
11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
12. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
13. If the bidder violates any of the terms of contract, Govt. shall forfeit the entire amount of Security Deposit.
14. From the date of engagement a plate showing "On Govt. Duty, Revenue & DM Department" be fitted in the front side and back side of the Vehicle.
15. The tender papers should be filled up properly and legible without any correction, over writing and must be typed neatly.


16. The Quotation complete in all respect should reach the undersigned on or before Dt. 18.07.2019 by 01.00 PM through Registered Post or drop the same in the drop box available in the Spl. Land Acquisition Cell, Collectorate, Sambalpur and shall be opened on dated 18.07.2019 in the office chamber of the undersigned at 03.00 PM in presence of the bidder and or their authorized representatives.
17. The application form of quotation / tender containing General Bid information and Terms & Conditions for hiring of vehicle etc. will be available with the Spl. Land Acquisition Officer, Collectorate, Sambalpur on payment of Rs.100.00 (Rupees One Hundred) only from dated 02.07.2019 to 17.07.2019 By 05.00 PM.
18. The successful bidder shall execute the Legal Agreement with the Spl. Land Acquisition Officer, Sambalpur as per the terms & conditions within 03 (three) days of acceptance of his/ her quotation.
19. The undersigned reserve the right to cancel this quotation call notice without assigning any reason thereof at any time before the finalization of quotation.
