Expression of Interest is hereby invited by the Superintendent, VSS Institute of Medical Sciences & Research, Burla, Sambalpur from the interested Drug Stores/ Registered supplier for empanelment to supply drugs, medicines & other items relating to the treatment of the patients like cath lab consumables, surgical items, Ortho implants, dialysis consumable to the patients of this hospital so as to reach this office of the undersigned on or before dtd. 14.11.2019 up to 5.30 P.M. through Regd.Post/speed post/courier only. The same will be opened by the Committee on the next working day at 12.30 P.M. in the office chamber of the undersigned.

The selection of the firms will be done by the Committee of the Institute. The approved firm will enter into an agreement for supply of their selected respective items. The firm/drug Store should furnish the following documents with self attestation along with their willingness in a sealed cover and superscribed as "Expression of Interest for Empanelment for supply of Medicines/Ortho Implants/Cath Lab Consumable/ Dialysis consumables etc." and due date is 14.11.2019.

The following documents should be furnished in their bid documents.

1. Registration Certificate of the Shop/Store.
2. Valid Drug License of the Drug Store/Shop.
3. GST Registration certificate.
4. PAN Card
5. Authorized documents relating to the land over which the Drug Store/Shop of the firm established.
6. The firm should have annual turnover of Rs.4,00,00,000/- (Rupees four crores) each year for the last three financial years.
7. The audited documents of Annual Turn over for last three financial years.
8. Income Tax Return for last 03(three) financial years.
9. The distance of the drug store or shop from the hospital premises should be mentioned in the offer clearly.
10. Any other documents supporting to this offer.

The undersigned/Committee reserves the full right to select or cancel any or all the offers of the firms with out assigning any reason thereof.

**THE TERMS & CONDITIONS ALONG WITH THE CRITERIA FOR EMPANELMENT
OF DRUG STORE.**

1. The distance of the Drug Store/ shop of the firm from the main hospital should be mentioned. Preference will be given to the Drug Store/Shop of the firm which is with in the 200 mtrs. radius of the main hospital building. If no medicine store/shop of the firm available with in 200 mtrs.radius, then beyond that those shops/stores will be considered.
2. The Drug Store/shop of the firm should be with valid license under Drugs & Cosmetic Act by Govt.(The proof of document to be furnished)
3. The Drug Store/shop of the firm should be established in the authorized land. (The document relating to this should be produced).
4. The Annual Turn over of the Drug Store/firm should not be less than Rs.04 crores per year for last three financial years.
5. It is the responsibility of the Drug Stores to supply all the medicines & other related items to the patients which are prescribed by the treating surgeons/ physicians. By no means, the patients should be harassed for supply of the required items. If any medicine to be procured is not available in the Medicine Store, it is the responsibility of the store to arrange it and supply it quickly. Supply of the drugs partly and denying the rest items of the prescriptions without valid reason will be viewed seriously, amounting to cancellation of empanelment.
6. The Medicine Store must have drugs not less than 75% of the commonly prescribed medicines of the hospital.
7. The Drug Store or Registered shop only to quote the % of profit of the medicines or other items to be taken over & above the purchase price. The authentic documents for purchase should be produced along with the bills for verification.
8. The medicines & other items should be supplied to the patients as and when required by them with proper requisition.
9. An agreement will be made with the selected firm for the period of 1(One) year which may be extended depending upon the smooth supply, availability of items with the firms.
10. The purchase price or MRP of the medicines or other items will be verified at the time of need. The firms should furnish the same to the undersigned or committee as & when required.

The selection of the firms will be done by the Committee which will be formed for the purpose. The approved firm will enter into an agreement for supply of the items with some terms & conditions.
