

**VEHICLE FOR AUCTION SALE**

Sealed Tender on plain paper with full address of Tenderers invited so as to reach the undersigned by 5.30 PM of 31.10.2019 for disposal of Govt. Vehicle (Mohindra Jeep) bearing Regd No. OR – 15 – C – 5105 of Model CL 500 MDI 6 SEATER 4 WD.

The Vehicle may be inspected by the tenderers in the office of the Tahasildar, Rairakhhol during the office hours between 10 AM to 5.30 PM from 15.10.2019 to 31.10.2019 on all working days before filing tender. Intending tenderers are requested to deposit earnest money of Rs.1000/- (One thousand) only in shape of Bank Draft of State Bank of India in favour of Tahasildar, Rairakhhol payable at Rairakhhol which will be refundable to the unsuccessful tenderers after finalization of tenders.

Tenderers received without Bank Draft of Rs.1000/- will be rejected summarily. The tender papers must be written in his/her own hand writing by the tenderers and the Bank Draft is to be attached to the tender and receipt number & date must be quoted in the tenders.

The sealed covers containing tender should be subscribed on the top in capital letters as "TENDER FOR AUCTION SALE OF GOVT. VEHICLE" and be dropped in the box kept for the purpose in the office of the undersigned. The sealed covers so received, will be opened in presence of the tenderers or their authorised representatives in the office chamber of the undersigned at 11 AM on 01.11.2019. The successful tenderer should deposit then and there 25% of the tendered amount and which will be accepted by the authority. The remaining amount shall be deposited within seven days from the date of acceptance of the tender failing which earnest money deposited will stand forfeited to Govt. without further reference to the tenderers. The 25% tender amount and earnest money are subject to adjustment at the time of final payment of the tender value. The successful tenderer should remove the vehicle from the site within 7(seven) days of depositing the full amount of tender money. Failing which the undersigned will not be responsible for any damage, pilferage or otherwise and no claim in this regard shall be entertained by the undersigned. The ground rent @ 1% of tendered money shall be charged for each or a part of the day till removal of the vehicle from the site. Where the ground rent so charged exceeds the sale price deposited, the tendered shall cease to have any right on the vehicle. The amount deposited by him/her shall be adjusted towards the ground rent and vehicle shall become the absolute property of Govt. free from all encumbrances. The undersigned reserved the right to accept/reject the tender without assigning any reason thereof. The upset price of the vehicle has been fixed at Rs. 32,000/-(Thirty two thousand) only and accordingly the vehicle will be sold on higher amount that the upset price fixed basing on the highest at tender offered.
