



N.B.:- 1. The service charge quoted by the bidder should not be equal or less than the TDS (except GST) amount to be deducted from the monthly bills. The bidder quoting the Service charges equal or less than the TDS (except GST) amount will be rejected out rightly. The bidder quoting fewer service charges above the TDS (except GST) amount will be awarded with the contract.


3. The take home remuneration of the deployed person should not be less than the minimum remuneration/wages fixed/notified by the Govt. of Odisha from time to time.
