ORDER


Whereas, the Government of Odisha vide R&DM (DM) Department Notification No. 1706/R&DM (DM) dated 13.03.2020 has declared COVID-19 as a "Disaster" under section 2(d) of the Disaster Management Act 2005 for the state of Odisha and promulgated Odisha COVID-19 Regulation 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act 1897 for containment of COVID-19.

And Whereas, the National Disaster Management Authority, Government of India in exercise of Powers conferred u/s 6(2)(i) of the Disaster Management Act, 2005, has directed the State Govt./State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said act to issue necessary guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide order No.1663/R&DM(DM) dated 31.03.2021.

Now, as the survey and testing have been completed in the Containment Zone made vide Order No. 4507/Emg. Dated 27.04.2021 i.e. **E2 Block, Hindalco Colony, Hirakud (Ward no.10) under SMC, Sambalpur is hereby rescinded with effect from 12.05.2021.**

However, the active surveillance in this Containment Zone will continue till next 07 (Seven) days as measure of containment of COVID-19.
