QUOTATION / TENDER CALL NOTICE.


Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals having GST registration for providing of Non AC/AC, petrol/diesel driven vehicle for Jujomura block of Sambalpur district, which shall conform to the Terms and Conditions (Annexure-II) for Mobile Veterinary Unit under Chief District Veterinary Officer, Sambalpur on monthly rent basis.

1. The vehicle must be in Road worthy condition, shall not be more than three years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of the vehicle. In view of pollution being high through use of diesel vehicles BS-IV compliant petrol is preferable. The vehicle must be of Bolero/Sumo Gold/TUV 300/Ertiga Type.
2. The driver of the vehicle must have a valid Driving Licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well-behaved, gentle and obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of the CDVO, Sambalpur and submitted along with the tender paper as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants). The hired Vehicles cannot be used for any private/commercial purpose beyond office hour or during holidays
6. The vehicles for different blocks must achieve fuel efficiency of minimum 10 kms. per litre.
7. The details of the make and year of manufacture of the vehicle, registration No., mileage (Kms covered per litre) and name of the driver with driving license no. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(Annexure-III).
8. The Quotation completed in all respect should reach the undersigned on or before 03 .06.2021 by 4.00 p.m. and should be opened on the same day at 5.00 p.m. in presence of the bidders or their authorized representatives.
