**ORDER**

Whereas, the Government of Odisha vide R&DM (DM) Department Notification No. 1706/R&DM (DM) dated 13.03.2020 has declared COVID-19 as a "Disaster" under section 2(d) of the Disaster Management Act 2005 for the state of Odisha and promulgated Odisha COVID-19 Regulation 2020 by virtue of the power conferred under section 2, 3 and 4 of Epidemic Disease Act 1897 for containment of COVID-19.

And Whereas, the National Disaster Management Authority, Government of India in exercise of Powers conferred u/s 6(2) (i) of the Disaster Management Act, 2005, has directed the State Govt. /State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said act to issue necessary guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide order No.3985/R&DM (DM) dated 15.07.2021.

And whereas, the positive cases of COVID-19 have been detected in **Jagannath Prasad of Naktideul G.P. under Naktideul Block.**

And whereas, urgent measures need to be taken for active contact tracing and social distancing.

Now therefore, in larger public interest and with a view to contain the spread of COVID-19, it is hereby directed to implement the following directions.

- (A) The following areas coming within the boundary as indicated below is hereby declared as under Micro Containment/ Buffer Zone. (Map Enclosed)



- (B) In the Micro Containment Zone, only essential activities shall be allowed. There shall be strict perimeter control to ensure that there is no movement of people in or out of this zone, except for medical emergencies and for maintaining supply of essential goods and services. There shall be intensive contact tracing, house-to-house surveillance and other clinical interventions as required. Guidelines of MoHFW shall be taken into consideration for the above purpose.


- (C) All vehicular movement, movement of public transport and personnel movement will be stopped barring extremely urgent medical cases with the permission of the undersigned. IIC, Naktideul PS will remain in charge of movement of vehicle/person in the containment area. He will issue required pass to the person going outside and coming inside with intimation to the Control Room.
- (D) Control Room having Police, Medical and Block staff will function at PM High School, Jagannath Prasad of Naktideul Block.
- (E) All inhabitants within the Micro Containment Zone and Buffer Zone shall strictly remain in home. All the shopping establishments of whatsoever nature shall be closed immediately. The supply of essentials and medical requirements will be ensured through various teams constituted under the Block Development Officer, Naktideul.
- (F) All the Govt. and Private institutions located within the boundary of the Micro Containment Zone shall remain closed.
- (G) All persons in Buffer Zone area are to wear mask and maintain social distancing. All non-essential activities to be avoided.
- (H) As a measure of perimeter control, all roads connecting the micro containment zone will be guarded by police.
- (I) IIC, Naktideul PS will maintain the law and order under the supervision of SDPO, Rairakhol. Tahasildar, Naktideul will be deployed as Executive Magistrate to maintain law and order under the overall control of Sub Collector-cum-Sub Divisional Magistrate, Rairakhol.
- (J) The containment period is effective from **7.00 AM of Dt. 20.07.2021** until further orders.

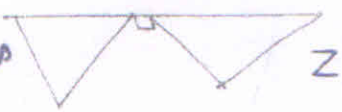

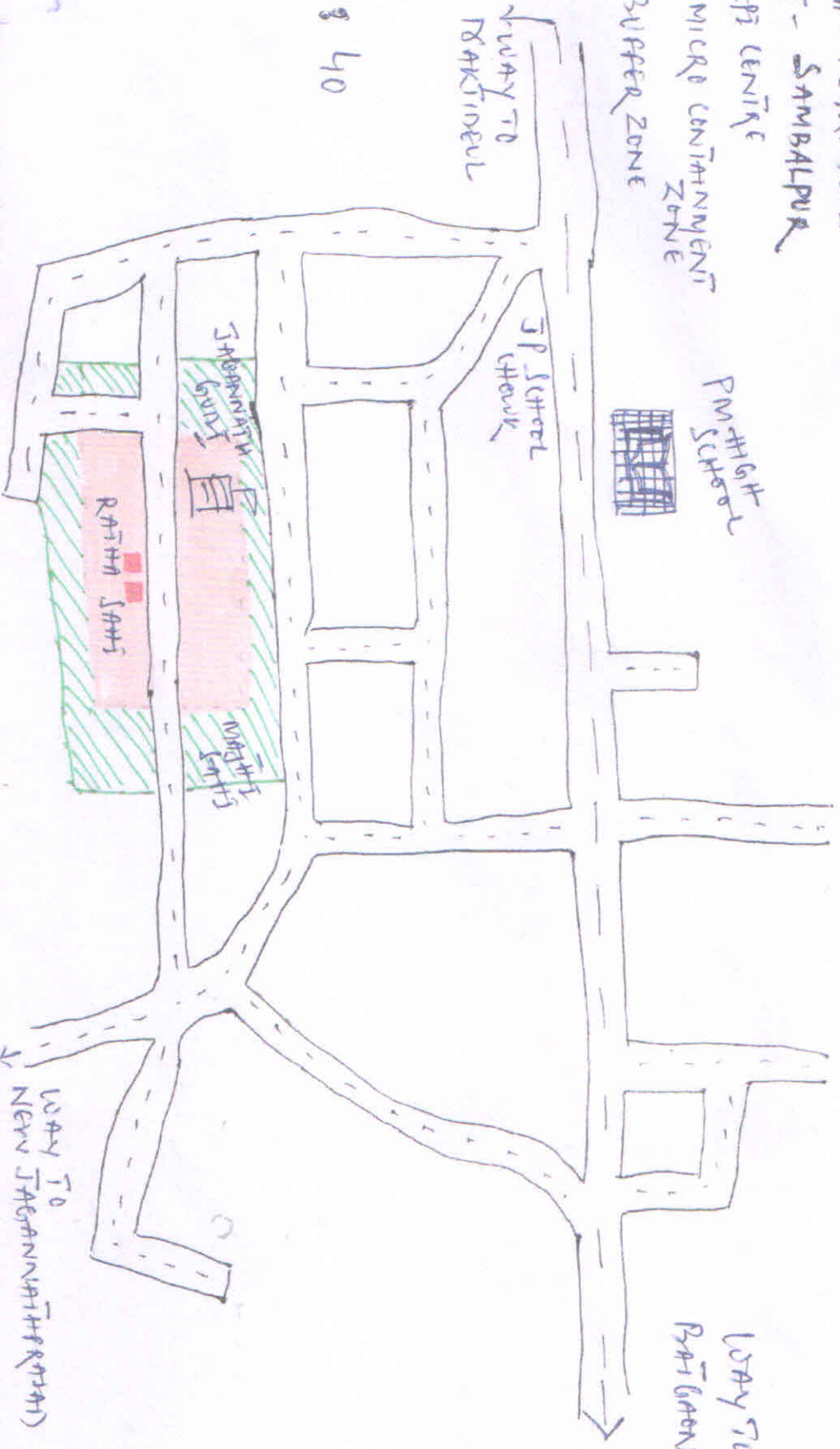
