Sealed quotations are invited in prescribed format from intending Firms/ Transport Contractors/ Individuals/ Transport Agencies having valid Transporting Agents license under Odisha Motor Vehicles(licensing of agent) Rule, 1990 for transportation of Medicines, Vaccines, Equipments and any other items from Directorate of AH& VS ,Odisha, Mangalabag, Cuttack & OBPI Bhubaneswar to Sambalpur and distribution of those items among the field institutions located in Sambalpur district during the financial year 2021-22 as and when required. The quotations along with requisite documents should reach in sealed cover to the CDVO Sambalpur on or before 2PM of Dtd. 11.08.2021. The quotations will be opened on 11.08.2021 at 4PM in the presence of the members of the Technical Committee and the Bidders or representatives of the Bidders. The quotations received beyond the scheduled date and time and shall not be taken in to consideration.

TERMS AND CONDITIONS

1. The quotations should be filled up properly and legibly without any correction, overwriting and must be typed neatly.
2. The quotations should be attached with experience certificate if any, with satisfactory performance duly obtained from Govt. Organisations only regarding transportation of valuable goods.,
3. Quotation will be finalized by the Technical Committee under the chairmanship of C.D.V.O. Sambalpur in presence of the Bidders or their representatives. The committee may finalize the quotation even in absence of the bidders/their representatives. No Individual ,Company, Firm, Transporting Agent shall be allowed to participate in the quotation process unless he/they obtain(s) or processes(s) valid Transporting Agents license under Odisha Motor Vehicle (licensing of Agents) Rule 1990 from the competent authority.
4. The Bidders should have at least one Truck of his own .Attested copies of supporting documents of the vehicle such as RC Book, Valid insurance, permit and fitness Certificate etc. to be attached with the quotation. The selected bidder may have to transport the stock as and when required.
5. Payments shall be made subject to the availability of funds. The authority shall have the rights to deduct any amount from the bills of the transporter towards any loss and damage or both. No advance payment shall be made nor can any interest be claimed for delay in payment.
6. Order will be placed to the successful bidders by the CDVO Sambalpur as per terms & conditions with acceptance of his/her quotation.
7. The Transporting Agent shall attend the office of CDVO Sambalpur as and when required to receive order and submit accounts etc.
