AUCTION NOTICE

1. Sealed tenders in plain papers for sale of Two nos. of Ambassador Car (Diesel) without accessories of the Office of the District Judge, Sambalpur bearing Registration No. **OR-15-H-4444 and OR-15-F-1111** with upset price as fixed by MVI, Sambalpur **Rs. 27000/- and Rs. 25000/-** respectively are invited so as to reach the undersigned on or before 16.08.2021. The intending parties should write in capital letters on the top of the envelope **"Sealed tenders for the vehicle No. -----"**. The tenders shall drop the sealed tenders in the box kept for the purpose at the Nizarat Section of the Office of the District Judge, Sambalpur between 11.00 A.M. to 4.00 P.M. on all working days.
2. The vehicles are available for inspection inside the Court premises on working days during the office hours between 11.00 A.M. to 01.00 P.M. from the date of publication of this notice.
3. Earnest money of Rs.1,000/- (Rupees One Thousand) only shall be deposited in shape of bank draft in favour of District Judge, Sambalpur for each vehicle and the bank draft be enclosed with the tender application. The tenders received without bank draft shall be rejected summarily.
4. The tenders shall be opened by the undersigned on dated 16.08.2021 during office hour at 3.30 P.M. in presence of the tenderers or their authorised representatives. The unsuccessful tenderers shall get return of their earnest money deposit bank draft forthwith.
5. The highest tenderer shall deposit 25% of the amount offered immediately on the spot soon after the announcement and the balance amount shall be deposited within seven days of the approval of the offer and on failure to make the payment, the deposit already made (including earnest money) shall be forfeited and the vehicle shall be put to fresh tender.
6. The vehicle shall be removed from the court premises by the tenderer within seven days from the date of depositing the full amount of tendered / negotiated money together with the VAT at the prescribed rate. The custody or safeguard of the vehicle shall be the responsibility of the tenderer / party and no claim or complaint on that account shall be admissible.
7. On failure to remove the vehicle within the time as aforesaid, ground rent @ 1% of the tendered / negotiated money shall be charged for each day or part of the day till removal of the vehicle from the site. In case the ground rent exceeds the sale price deposited, the party will cease to have any right over the vehicle and the amount deposited towards the sale proceeds will be adjusted towards the ground rent and the vehicle shall become the absolute property of the Court free from all encumbrances.
8. The authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
