



TERMS & CONDITIONS OF SEALED QUOTATION CALL FOR SUPPLY OF ONE PAIR

FOOTBALL MOVABLE GOAL POST & ONE PAIR MINI GOAL POST FOR  
DISTRICT ATHLETIC ASSOCIATION, SAMBALPUR

1. The Sealed Quotation are invited through Speed Post / Registered Post only by the District Sports Office, Collectorate, Sambalpur from 19.08.2021 to 31.08.2021 by 5:00 P.M.
2. The Quotation received beyond the stipulated date & time will not be taken into consideration.
3. The sample of Sports items should be produced at the time opening of the Quotation.
4. The rate to be quoted shall be inclusive of all taxes, transportation, loading and unloading charges and will be delivered in the Office of the District Sports Office, Sambalpur.
5. After selection of the Sports materials the bidder should supply the items within 7 days from the date of receipt of supply order.
6. The Bidders are required to submit one sample sports item/equipments during the opening of the Quotation. The sample of unsuccessful Bidders will be returned after finalisation of Quotation. The sample of successful bidder will be returned on their written demand after the final payment.
7. Payment shall be made after verification of the quality / specification of the Sports materials etc.
8. The Quotation paper duly signed by the bidder as a token of acceptance of terms & conditions of the Quotation must be appended with a copy of GST registration certificate, PAN Card.
9. The copy of Income Tax return for the financial year 2019-20 & 2020-21 should be attached.
10. The Quotation paper should be filled in properly and legibly without any correction, overwriting and must be a typed copy. The rate should be written in words and figures in the tender.
11. Photo copy of Authorised dealership certificate should be submitted along with the Quotation paper.
12. Quotation submitted without up to date PAN Card, GST registration certificate and Income Tax return as mentioned above are liable to be rejected.
13. The successful bidder of dress materials are required to print the logo of "NLCIL & District Athletic Association, Sambalpur" on the football goal posts.
