Interested firms may submit their tender super-scribing as “**Printing of MGNREGA Job Cards**” as to reach the undersigned on or before 02:00 P.M on 05/07/2018 ----- . It will be opened on the very same day at 04.00 P.M. in the Office Chamber of Dy. Development Commissioner, Dhanbad. After mentioned date & time no firm will be entertain.

Technical Bid

1. GST Registration Certificate
2. NOC from sales tax Department
3. ITR of last three years
4. Firm Registration certificate updated
5. Security Money- Demand Draft of Rs. 20000.00 in favour of Dy. Dev. Commissioner, Dhanbad Payable at Dhanbad.

Price Bid

1. Price Bid should be submitted in separate envelop.
Single Price should be quoted. no alternative price shall be accepted.

Terms & Condition

1. Job card having a 30 pages with cover (approx) and the format and print matter will be received from drda office

Job Card Pages	Size	cover pages
30 Pages (90 GSM Maplitho paper with single colour printing and 85 percent brightness. The inner pages may be White in colour and the printed text may be in Black) Both sides	A5	300 GSM glossy paper. The inner and outer portions of the front and back cover pages may be laminated, and multi - colour printing is suggested for these pages. Variable data printing may be enabled on the cover pages. Background colour of the cover pages on the front and back may be Yellow in colour and the text may be in Blue

2. Technical bids should be opened first, those who qualified in the technical bid, only the Price Bid of such qualified firms shall be opened.
3. Sample of job Card paper should be submitted separately at the time of submission of tender papers.
4. Sales Tax/GST and any other local taxes should be clearly mentioned separately in terms of percentages in the price bid.
5. Each Bidder shall submit only one bid.
6. The purchaser reserves the right at the time of placement of purchase order to increase or decrease the required quantity depending upon demand.


7. Before printing the job Card the supplier shall receive the samples from DDC, Dhanbad and submit proof copy of necessary verification for final printing, otherwise the wrong printing material will not be accepted and no payment will be made for those items.
8. The Delivery should be completed with in -30 days from the date of receipt of the confirmed purchase order.
9. Any delay by the supplier in the delivery of the Job Card shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part therefore subject to a maximum 10% of purchase order value which will be deducted from the payment due.
10. No transportation and delivery charges will be made to the selected firm.
11. Before delivery the selected firm will be informed to this Office for inspection.
12. The quality of the paper may be tested if required in any laboratory within or outside the state to ascertain the quality of the paper.
13. Payment will be made only after complete delivery as per order subject to submission of bills along with delivery challans.
14. The bids are liable to be rejected if any of the conditions are not complied with.
15. The undersigned have all the rights reserved to accept and reject the tender without assigning any reason there of.
