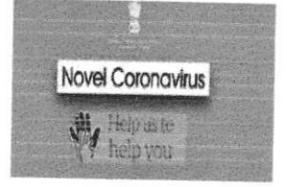

**ORDER**

It was deliberated in the meeting of District Crisis Coordination Committee held on 12.06.2020 under the chairmanship of undersigned that the list of containment zone needs to be revised due to the additional number of Corona positive cases found in the district. Therefore, as per the guidelines issued by Ministry of Health and Family Welfare, Government of India, the list of containment zones has been revised under the current circumstances.

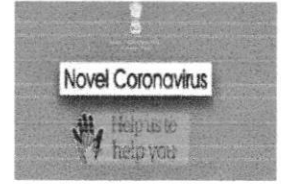
Thus, it is hereby ordered that as of today i.e. 12.06.2020, the following places are declared as containment zones in the district Mahendragarh. All directions issued by district administration, Government of Haryana and Government of India with respect to Containment zones will strictly be followed in the below mentioned containment zones. **It is also mentioned that the incident commanders will be sole responsible for all necessary actions in the Containment Zones.** The Additional Deputy Commissioner, Narnaul will be Overall Incharge in the Jurisdiction of District Mahendragarh.

List of Containment Zones of District Mahendragarh is as following with a buffer zone of 200m beyond perimeter in urban and 1000m in rural areas:-
