Subject: **Compliance with the instructions of wearing masks and challaning of violators – reg.**

The Central Government and the State Government have made it very clear that in the interest of public safety during the prevailing of pandemic wearing of Face Cover whether a mask, an improvised mask, a home-made mask or a fact cover using clean clothes shall be mandatory for every person while being in public places and a workplace also.

Also, there is need of strict prohibition of spitting in public places.

In view of the aforesaid instructions of the Government, every violation of the said prohibitions has to be punished by imposing fine of Rs. 500/-. Non-payment of the fine by the violator will attract proceedings under section 188 of IPC.

In addition to the above, in compliance with the directions of Hon'ble Urban Local Bodies Minister and in continuation of ULB department's letter No. ADULB/Admn./2020/29603-04 dated 29.05.2020 regarding issuing of challans to person not wearing/using masks, all Municipalities have been directed to constitute dedicated teams with strict instruction to issue challans in large numbers to such violators.

But, it has been observed by the undersigned during the surprise checking today, the 13th of June, 2020 in the M.C. areas of Nangal Chaudhary and other villages that a number of persons are not adhering to the instructions of the Government for which the purpose of the same is defeated.


It has, therefore, been decided that all the addressee officers will exercise their powers for challaning of the both the violation mentioned above, strictly as per instructions.

Addl. Deputy Commissioner, Narnaul shall be overall Incharge for implementation of these instructions in letter & spirit. All the challaning officers will report of challans done in this regard to the Addl. Deputy Commissioner, Narnaul on daily basis for further submission to the undersigned.

Challan book, if required by any officer, may obtain it from the office of the Addl. Deputy Commissioner, Narnaul.

All the BD&POs, E.O., M.C., Narnaul and Secretaries of all Municipal Committees in this district are directed to announce and make aware the people in their respective areas to wear masks and not to spit in the public place for the containment of spreading COVID-19 in the district of Mahendragarh.
