ORDER

Whereas the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Haryana State Disaster Management Authority, Haryana, Chandigarh has directed all District Magistrates, Superintendents of Police and Haryana State Pollution Control Board vide Order No. DMC-SPIO-2020/13250 dated 09th November, 2020 to ensure the implementation of the order of Hon'ble NGT dated 09.11.2020 (copy of order alongwith OA No. 249 of 2020 enclosed herewith) in letter and in spirit with immediate effect. It has also been directed that appropriate enforcement guidelines in consonance with the directions of Hon'ble National Green Tribunal may be accordingly issued.

And whereas, as per directions of the Hon'ble National Green Tribunal, there will be total ban against sale or use of all kinds of fire crackers in the NCR from midnight of November, 9-10, 2020 to the midnight of November 30 - December 1, 2020, to be reviewed.

Now, therefore, in view of aforesaid directions, **I, Ajay Kumar, IAS, District Magistrate-cum-Chairman, DDMA, Mahendragarh at Narnaul**, in exercise of the powers conferred by Section 30 of the Disaster Management Act, 2005, do hereby prohibit the use of any type of fire crackers within the territorial limits of District Mahendragarh from midnight of November-9-10 to the midnight of November 30 - December 1, 2020.

It is further directed that the Superintendent of Police, Mahendragarh at Narnaul, Additional Deputy Commissioner, Narnaul, C.E.O., ZP/DRDA, Narnaul, Sub Divisional Magistrates-cum-Incident Commanders and City Magistrate, Narnaul-cum-Incident Commander in the district of Mahendragarh, District Development & Panchayat Officer, Narnaul, Regional Officer, HSPCB, Dharuhera, all BD&POs, all Tehsildars, all Naib Tehsildars, all DSPs, EO/Secy. Municipal Council/Committees, SHOs of all police stations and Fire Officer, Narnaul & other fire department staff shall ensure the compliance of this order.

All the officers are required to comply with the instructions for vast public awareness campaigns in this regard in the district of Mahendragarh as well as to conduct inspections/raids, alongwith SHO concerned, wherever necessary and initiate penal action as warranted.

Any person violating this order will invite immediate penal action under Section 51 to 60 of Disaster Management Act, 2005 besides legal action under Section 188 of the IPC and others provisions as applicable.

The order shall be promulgated in the area of district Mahendragarh by affixing copies of this order on the Notice Boards of District, Sub Divisional, Tehsil Offices, other Public Places, by beat of drum,

announcement through the publicity van of Information & Public Relations Department, publications in the newspapers having circulation in the area through the office of the DIPRO, Narnaul and publicity may also be carried out through social media.

ADIO, NIC, Narnaul is directed to host this order on the official website <https://mahendragarh.gov.in> of district Mahendragarh.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the Public at large.

Strict compliance of the above directions be ensured by all the concerned.
