

**OFFICE OF THE DISTRICT MAGISTRATE,**  
**MAHENDERGARH AT NARNAUL**

**Order**

Whereas, the DDMA, Mahendergarh is satisfied that the residents of District Mahendergarh are threatened with the spread of COVID-19 pandemic, and has considered it necessary to take effective measures to prevent its spread in the District Mahendergarh.

And whereas many persons have been tested positive for COVID-19 in the following areas thus indicating higher positivity rate in these areas. So, on the request of CMO, Narnaul and in view of guidelines/ advisories issued by the Government the following areas are, hereby, declared as Macro Containment Zones:

1. Idgah Colony from trunk factory to end of street.
2. Tigra-House of Vijaypal to House of Roop Vasant.
3. Bawania-House of Mahesh to shop of Babu Lal.
4. Agihar-Adani group power plant.

The assembly of people in these areas is strictly prohibited and the movement of persons will be restricted. The markets/shops/religious places etc. in these areas will remain closed.

For carrying out aforementioned orders following directions are necessary to be issued:

1. To ensure the deployment of sufficient police force to restrict the entry and exit of persons in the macro containment zone and also by way of putting up Nakas to control the movements to and from the aforesaid containment zone and keep the above mentioned places closed.

**(Action by : Superintendent of Police, Narnaul/ DSP, HQ, Narnaul)**

2. To ensure the sanitization of the entire area of containment zone and also to make necessary arrangements for disposal of solid waste from this area.

**(Action by: EO, MC, Narnaul/ All Secretary, MCs, Distt. Mahendergarh )**

3. To ensure deployment of sufficient number of teams of Doctors and Paramedical Staff for conducting door to door survey for screening of persons having Flu like symptoms through out the macro containment zone and to keep the regular surveillance and also trace all the contacts of above persons and their family members and put them under isolation immediately.

**(Action by: Civil Surgeon, Narnaul)**

4. To ensure uninterrupted supply of essential items (Grocery, Milk, Vegetables, Fruits etc.) to and from macro containment zone.

**(Action by : DFSC, Narnaul)**



5. To ensure the timely supply of medicines in macro containment zone.


**(Action by : Drug Controller Officer, Narnaul)**

Duty Magistrates appointed via Memo No. 270-71/MA dated 24/04/2021 in their respective thana area will take all possible measures to sort-out the problems of the residents and ensure smooth supply of essential commodities, food, fodder, seeds, fertilizers etc. by exercising the powers of Executive Magistrates.

Additional Deputy Commissioner in Mahendergarh at Narnaul the overall incharge and All SDMs of the containment zone to oversee all the arrangements.

All the above officers shall discharge their duties efficiently and any laxity on the part of any officers will attract strict action under the provisions of Disaster Management Act, 2005.

Any person violating these measures will be liable to be proceeded against as per the provisions of Sections 51 to 60 of the Disaster Management Act, 2005, besides legal action under Sec. 188 of the IPC and other legal provisions as applicable.


