


Order

Keeping in view of demand of oxygen supply for the home isolated COVID patients in District Mahendragarh at their doorsteps, rates for Home Delivery of Oxygen Cylinders are hereby fixed as following manners:-

1. If the patient is not having the oxygen cylinder, he has to pay the Rs. 10,000 as security amount for the "D Type Cylinder" and Rs. 5000 for the "B Type Cylinder". The Security amount is totally refundable.
2. If the patient is having his own Cylinder, the Oxygen Refilling charges for "D type Cylinder" is Rs. 430 and for "B Type Cylinder" is Rs. 150.
3. For the delivery of Oxygen Cylinder at Home then transportation cost will be Rs. 100 for D type Cylinder and Rs. 50 for B type cylinder. Transportation charges will be deposited in the Account of District Red Cross Society, Mahendragarh.


