

I, Ajay Kumar, IAS, District Magistrate, Mahendragarh do hereby fix the rates of hiring charges of ambulances to be used by the citizens for transporting patients in district Mahendragarh. The rates of hiring charges will be as follows:

1.	BLS without Oxygen (Eeco/Bolero/Van/Cruiser)	Rs. 350/-	Rs. 12/- per K.M.
2.	BLS With Oxygen (Eeco/Bolero/Van/Cruiser)	Rs. 350/-	Rs. 12/- per K.M. Rs. 300/- Extra Per Oxygen Cylinder D-Type
3.	AC ALS Without Staff (Force.Tempo Treveller/Wingger)	Rs. 750/-	Rs. 30/- per K.M.
4.	AC ALS With Staff (Force.Tempo Treveller/Wingger)	Rs. 1250/-	Rs. 30/- per K.M. Rs. 300/- Extra Per D-Type Oxygen Cylinder
5.	Dead body 10 K.M. Free	0 to 10 K.M. Free	Rs. 15/- per K.M. (He used PPE Kit).

If any private ambulance service provider is found charging over the prescribe rates, legal action shall be initiated under section 51-60 of Disaster Management act, 2005 and epidemics act 1897.


