In compliance of the order issued by the Haryana State Disaster Management Authority, Chandigarh vide order No. DMC-SPO-2020/5761 dated 23.05.2021 and keeping in view the prevailing conditions due to Covid-19 pandemic in the district, I, Ajay Kumar, IAS, District Magistrate-cum-Chairperson, District Disaster Management Authority, Mahendragarh, in exercise of powers conferred upon me under section 30 & 34 of the Disaster Management Act, 2005, hereby fix the timing of opening of shops during lockdown period in the larger interest of public health in the district Mahendragarh.

Sr. No.	Shops	Timing
1.	Grocery shops & shops selling hygienic items.	07.00 AM to 06.00 PM
2.	Stand-alone Shops	07.00 AM to 06.00 PM
3.	Other Shops (Non-essential)	07.00 AM to 12.00 PM (Odd-even basis)


National directives for Covid-19 management, SoPs and general preventive measures such as use of face mask, frequent hand washing and social distancing shall be followed by all.

These orders shall come into force w.e.f. 24.05.2021.

Superintendent of Police, Addl. Deputy Commissioner, all SDMs, all SHOs, EO and all Secretaries, Municipal Council/Committees, all BDPO's and all Duty Magistrates shall strictly enforce these directions and take appropriate action against the persons found violating these directions as per section 51 to 60 Disaster Management act 2005.

The marking of shops as odd/even is to be done by EO/Secretaries of Municipal Council/Committee in urban areas and BDPOs in rural areas.

The District Information and Public Relations Officer shall give a wide publicity and disseminate this information through all modes of communication throughout the district.




