Whereas, there is an apprehension that use of firecrackers may endanger the health and safety of human life particularly of old age persons, infants, children, persons with comorbidity, persons suffering from respiratory disorders and covid-19 affected persons. Therefore, it is necessary and expedient in the public interest to prohibit the manufacture, sale and use of firecrackers within the limits of District Mahendragarh.

Hence, in compliance of instructions received from Haryana State Pollution Control Board, I, Ajay Kumar, I.A.S., District Magistrate, Mahendragarh exercising powers vested upon me under Section 144 of CrPC,1973, the Explosive Act, 1884 & the Explosive Rules and other enabling powers as District Magistrate, Mahendragarh, do hereby, prohibit the manufacture, sale and use of all kinds of fire crackers within the limits of District Mahendragarh.

Further, District Education Officer, Mahendragarh, is, hereby directed to educate school and college students about the ill and harmful effects of the firecrackers through seminars, workshops, discussions etc.

Furthermore, Regional Officer, Haryana State Pollution Control Board, Dharuhera, is, hereby, directed to monitor the air quality regularly and upload the data on the relevant websites.

The Superintendent of Police, Mahendragarh, District Municipal Commissioner, Mahendragarh, All Sub Divisional Magistrates, All Tehsilders/Naib Tehsilders/BDPOs, DSPs, EO/Secy, Municipal Council/Committees, SHOs of all police stations, Assistant Divisional Fire Officer, Mahendragarh and other fire office staff shall enforce this order in letter and spirit. All the above mentioned officers are, hereby, directed to conduct the raids, along with the SHO concerned, to enforce this order and submit the reports about the raids conducted on a daily basis to the office of the undersigned.

Non-compliance/violation of this order shall attract relevant penal action as per IPC, the Explosive Act, 1884 and the Explosive Rules, 2008.

The District Information and Public Relation Officer, Mahendragarh is directed to aware the public about the ill and harmful effects of fireworks and cautioning people about the health hazards of bursting fireworks through nukkad nataks, print and electronic media. Further, she is directed to give vide publicity to this order throughout the District Mahendragarh and this order should be sent to the press for vide publicity. ADIO is directed to host the order on official website of district administration www.mahendragarh.gov.in.

This order shall come into force with immediate effect and will remain in force up to 20.11.2021.

In the view of emergent situation, this order is passed ex-parte and is addressed to public at large.
