2. Offers Invited In Two Envelope


All agencies are required to submit their Technical and Financial offers in to covers (in duplicate) as under: -

A. First (Technical Envelope) Should Contain:-

1. Name of the firm with full address & contact no.
2. Documents duly completed and signed but without indicating the rates.
3. Applicants should attach their self-certified Audited Balance sheet of last three years with P/L Accounts.
4. The agency should attach ITR filed for last 3 years.
5. The bidder should not be black listed (an affidavit for this purpose is to be necessarily attached).
6. The bidder should have a minimum of 1 years' experience in implementing similar work or in the education sector and at least 1 year with any Govt Office/PSU.
7. The Certificate of registration under Goods & Service Tax Act 2017/Exemption certificate along with latest returns should be attached.

B. Second (Financial Envelope) should contain :-

- a. Rates Should be quoted in Indian rupees which should be inclusive of all types of Government Taxes, Freight, Packing and other expenses. This Should be in their letter pad.
- b. Conditional or incomplete applications will not be accepted.
- c. Price bid of all those bidders will be considered for opening whose offer is complete and technically sound.
- d. The applicant may enclose copies of the orders received, if any from government/semi government organizations in the recent past for the subject stores along with the tender. Such bidder will be preferred.
- e. Qualified applicants should be in a position to demonstrate their products, ideas, etc at Gumla on their own cost before the Sanctioning committee on a date and place fixed for the purpose.
- f. The undersigned reserves the right to reject the tender partially or fully without assigning any reason.
