

## ORDER

Now, therefore, exercising the powers vested in me under section 22(i) and 23(ii) of the Code of Criminal Procedure, 1973, **I, Preeti, IAS, District Magistrate, Panipat** do hereby appoint the following Officers as Duty Magistrate with immediate effect till further order to maintain law and order situation in the area given hereunder to them.
