ORDER

W.H.O. has declared the recent Novel Corona Virus (COVID-19) epidemic as Public Health Emergency of International Concern. Since evidence of local transmission of the disease has been found in many countries including India and the infection typically spread from one person to another via respiratory droplets produced during coughing and sneezing, therefore, to mitigate the risk of COVID-19, contact/gathering of people in large numbers needs to be restricted and complete lockdown necessitated.

During the lockdown in District Panipat following Industrial units are exempted from Lockdown. **Transportation related to these units is also exempted. Essential labour and Staff which is compulsorily required to run these Industries are also exempted.** Hence they do not require any pass to travel during lockdown:-

- Food. Food products and other allied Industries including Rice Mills.
- Milk, Milk products and allied Industries.
- Face Mask.
- Hand Sanitizers.
- Disinfectants, alcohol and bleach based.
- Packaging Industries working for Food and Pharma Industries.
- All Pharmaceuticals and Medical Industries.
- Poultry/Meat/Fishery Processing unit.
- Food Irradiation unit etc.
- Cattle/Poultry Feed.
- Industrial units manufacturing water purifiers and purified water.
- Industries manufacturing equipments/materials used in Public Health Services.
- Electric generation distribution and transmission.
- IT services, IT enabled services and Data Centres providing services to any essential Industries.
- Production transportation and supply chain, E-Commerce of all essential goods including food, fast moving consumer goods, pharmaceuticals, sanitizers, masks, pest/insect control and Medical equipments, Warehousing of all essential food, grocery, grains.
- Factories/Production Sites/ Commercial Entities shall be allowed to have security and fire fighting personnel present.
