ORDER U/S 144 Cr.P.C

Whereas, it has been brought to the notice of the undersigned that, All East Siang District Students' Union (AESDSU) has called for phase wise District Bandh w.e.f 28/06/2018 from 05:00 a.m to 05:00 p.m in the entire territorial jurisdiction of East Siang District in connection with their demand intimated to the undersigned vide No. AESDSU-02 Dtd. 22/06/2018.

And whereas, the District Administration, East Siang District had called a Consultative Committee Meeting of all the stakeholders including authorities of All East Siang District Students' Union on 26/06/2018 to discuss the issue and to find out an alternative means of protest in a democratic manner on the issue raised by the said Students Union of the district wherein the District Administration and all the officers/Senior citizens and public leaders attending the said meeting had suggested and advised the said Union to go for other methods of protest like Dharna etc. in place of Bandh called given.

And whereas, such Bandh called shall definitely have an adverse affect on the entire normal day to day economic activities of the district including normal functioning of the various Govt. establishments/ functioning of Educational Institutions / Students appearing classes and examinations/trainees undergoing classes of Youths selected for written examination of Indian Army Recruitment / Daily wage earners of petty Business Community / Movement of various Agri/Horti. Farmers/ Movement of transportation services in the district/ other unforeseen sudden emergency related issues etc. in the district.

And Whereas, "the Hon'ble Supreme Court of India in its Judgment in Civil Appeal No. 7728/29 of 1997 (CPI-Vrs-Bharat Kumar & Ors) declared any Bandh called by any Political parties, Organizations or Associations or Groups or Individuals as Illegal".

And Whereas, vide Govt. of Arunachal Pradesh Notification No. HMB (B)-43/2000(Part) 51 Dtd.22/01/2015 "the Arunachal Pradesh Unlawful Activities (Prevention Act) 2014 (Act No.14 of 2014) came into force with immediate effect from 20/01/2015" in the entire territorial jurisdiction of Arunachal Pradesh.

And Whereas, in the interest of public and all the common citizens of the district and normal functioning of all the educational institutions and various Govt. establishments etc., it is felt expedient to maintain Law & Order at all cost during the said Bandh called given by All East Siang District Students' Union in the entire Administrative Jurisdiction of East Siang District.

And therefore, under the premises above and the power conferred upon me under the provisions of Section 144 Cr.P.C, I Tamiyo Tatak, District Magistrate East Siang District do hereby declared the said phase wise Bandh Called given by All East Siang District Students' Union w.e.f 28/06/2018 from 05:00 a.m to 05:00 p.m onwards as Illegal and henceforth, do hereby prohibit picketing /strike /blockade or obstructions of road/ bridges /forceful closure of Govt. office establishments/commercial establishment / educational institutions/ movement of transportation services etc. in the entire Administrative jurisdiction of East Siang District by the Bandh callers with a direction to called off the proposed bandh by the said Students Union.

Further, carrying of any kind of lethal weapons such as Arms & Ammunition/ Daos/Sword/Arrows & Bows/knives/daggers/ lathis etc. including movement of persons in groups more than five at a time in a particular place other than the group movement of Police and Security personnels for law & order duty is strictly prohibited in the entire jurisdiction of East Siang District.

Responsibilities of any damaged caused to the life and properties if any shall be fixed upon the Bandh callers and cost for such lost caused shall be recovered from the Bandh Callers.

The Superintendent of Police, East Siang District is enjoined upon to implement this order in letter and spirit with a direction to take necessary steps and to ensured deployment of necessary police/security personnels at vulnerable locations in the entire jurisdiction of the district.

The ADC-cum-Executive Magistrate(HQ) and EAC(Judl)-cum-Town Magistrate for District HQ and all the ADC/EAC/CO-cum-Executive Magistrates of all the outpost Administrative circles shall make necessary deployment of Executive Magistrates to lead the Police/Security personnels deployed during the period of Bandh called by the said Students union throughout the district to prevent any breach of law & order in their respective jurisdictions and ensured peace and tranquility at all cost. The CO(tpt) shall provide necessary vehicles to the Police/ Security forces and the Executive Magistrates with sufficient Pol items during the period of bandh with proper records.

The violators of this order shall be booked under appropriate provisions of law including 188 IPC for further prosecution and punishment.


