**ORDER**

In continuation to this office order No. DCP/MED/COVID-19/542 Dtd. 19/04/2020 and in pursuance of the Govt. letter No. CS/COVID-19/01/2020/26 Dtd. 24/04/2020, the following activities are also permitted within East Siang District with immediate effect subject to compliance with SOP for Social Distancing in Offices, Workshops, Factories, any other establishments etc.

1. Food processing industries in rural areas i.e. outside the limits of Municipal corporation and municipalities.
2. Industries operating in rural area, including stone crushers, Saw mills, brick kilns in rural areas i.e.. outside the limits of municipal corporations and municipalities.
3. Collection, harvesting and processing of Minor forest Produce (MFP)/Non Timber Forest Produce (NTFP) by Scheduled Tribes and other forest dwellers in Forest areas.
4. Bamboo, Coconut, Areca nut, Cocoa, Spices plantation and their harvesting, processing, packaging, sale and marketing.
5. Construction activities in rural areas for water supply and sanitation, laying/erection of Power Transmission lines and laying of telecom optical fiber and cable along with related activities.
6. Functioning of research Establishment dealing with agriculture and horticulture activities.
7. Shops of educational books for students.
8. Shops of electric fans.
9. Recharge facilities for prepaid mobile connection.
10. Shops, including ration shops (under PDS), dealing with food, groceries, fruits and vegetable, dairy and milk booths, meat and fish, animal fodder, fertilizers, seeds and pesticides.
11. Delivery of all essential goods including food, pharmaceuticals, medical equipment through E-commerce.
12. Capital and debt market services as notified by the Securities and Exchange Board of India.
13. Cold storage and warehousing services.
14. Private security services.
15. Farming operations by farmers and farm workers in the field.
16. Shops of agriculture machinery, its spare parts (including its supply chain and repairs to remain open.
17. Operation of fishing (marine)/aquaculture industry, including feeding and maintenance, hatcheries, feed plants, commercial aquaria, movement of fish/shrimp and fish product, fish seed/feed and worker for all these activities.
18. Selling of Gutka, Pan, Tobacco products strictly prohibited.
19. All other establishments may work from home only.

Further, the timing of opening of all kind of shops mentioned in this order is restricted from 07:00 A.M to 02:00 P.M for ensuring better social distancing considering the present COVID-19 outbreak.

The main vegetable market to resume activities in Gidi Notko (Solung festival ground) from 28/04/2020 onwards with timing from 07:00 A.M to 02:00 P.M.

EAC(Judl) and OC, PS Pasighat should make necessary arrangements to ensure social distancing in Pasighat Market complexes.

SDO(S), ADC(HQ) and OC PS Pasighat should make necessary arrangement of social distancing and listing of vegetable vendors at Gidi Notko.

Compliance of regulation issued vide order No. DCP/MED/COVID-19/574 Dtd. 22/04/2020 for wearing of mask, prohibition of spitting at public places, maintenance of social distancing etc. is mandatory.

All Admin. Officers, Superintendent of Police, East Siang is hereby enjoined upon to implement this order in letter and spirit.
