**ORDER**  
(U/S 144 Cr.P.C)

WHEREAS, in view of prevailing situation due to the outbreak of COVID-19 pandemic and reportedly increase in COVID-19 cases by the returnees from various part of the Country.

WHEREAS, owing to the spread of COVID-19, there is an apprehended danger for loss of human life, health and safety which may disturb public peace and tranquility.

WHEREAS, in order to prevent the spread of COVID-19, it is necessary to prohibit certain activities within the jurisdiction of Sadar area, Pasighat township and rural peripheries, Yagrung Circle and Sille-Oyan Circle.


AND THEREFORE, in the greater interest of public, I Dr. Kinny Singh, IAS in exercise of the Powers conferred upon me Under Section 144 Cr.PC do hereby prohibit all kind of movement including that of individuals, vehicular movement w.e.f 07:00 A.M of 13/06/2020 upto Mid night of 14/06/2020 throughout the Pasighat Sadar/ township area its rural peripheries, Yagrung Circle & Sille-Oyan Circle. Medical emergencies/essential services, movement of supply chain, staff engaged in COVID duty, Magistrate, Police/enforcement vehicle shall be exempted.

This order is addressed and applicable to all general public of Pasighat Sadar/ township area and its rural peripheries.

The Superintendent of Police, East Siang District and all Admin. Officers of Pasighat HQ are hereby enjoined upon to implement this order in letter and spirit.

Since the nature of the order is urgent, the order is being passed ex-parte and will come in force w.e.f 13/06/2020 till 14/06/2020.
