ORDER

In view of the Notification issued by Secretary Health Government of Arunachal Pradesh vide No. Secy(Health)/SOP-ii/2020/1342-48 Dated, Naharlagun the 23rd June 2020, the following arrangements for management of Returnees are made for East Siang District

All the returnees will be put up in Paid quarantine Hotels (selected in batches) and bear their own lodging and fooding and transportation expenses entirely. Everyone will abide by the terms and conditions.

The General guidelines formulated for strict compliance by all concern are :-

1. All returnees for advance booking may contact @7628055420 till the online booking app is developed.
The above phone number will be active from 9 a.m to 5 p.m only.
Only the people with advanced and confirmed booking will be allowed to enter the Check Gate.
2. The status of room availability can be viewed at the Official site of www.eastsiang.nic.in at COVID -19 page after 7 p.m.
3. Only the Permanent and Temporary residents of East Siang District will be allowed to enter the district and avail Quarantine services as per the SOP issued by Government of Arunachal Pradesh.
4. These Categories of people should possess valid PRC/ILP/E-pass/TRC/Govt ID Card/permission issued by the Commissioner Home, Itanagar.
5. All the Hotel owners are directed to provide fresh set of bedsheet, pillow cover, Towel and blanket in all the rooms. However the returnees are advised to bring their own light bedding as extra precautionary measure to prevent any cross contamination .
6. The returnees can be provided food from their own homes in disposable packets.
7. However, the parents/family members are not allowed to enter the hotel premises. They will hand over the packets with clear mention of room details to the Hotel Manager for delivery of the same.
8. A small table will be placed outside each room by the Hotel Management for delivery of materials etc.
9. All normal Amenities including Electric kettle for hot water may be provided in each room.
10. **However the cleaning of the room and the bathrooms will be attended to by the returnees themselves to prevent spread of any contamination.**
11. Direct Contact with the returnees should be avoided and communication be done through mobile only to the extent possible.
12. All are advised to maintain restraint for a calm and peaceful stay.
