Declaration of all Government Premises as Tobacco Free Zones.

**ORDER**

No: 44 DDCU of 2019

Date: 07 .09.2019

All the Government premises of District Udhampur including Buildings, Schools, Colleges, Hospitals, and Offices are hereby declared as Tobacco Free Zone / No Smoking Zone with immediate effect. It shall be the responsibility of all the District / Sectoral officers of the district that no individual shall use Tobacco product within the premises of his / her office / institution. Disciplinary action shall be initiated against the Government officer / official found using Tobacco product within the Government Premises.

Besides this, the sale of tobacco products within the 100 yards of any Educational Institution (Schools / Colleges) in District Udhampur is also banned with immediate effect.

It is further directed that all the Authorized Officers under Section 4 & Section 6(a) & 6(b) of COTPA-2003 shall get their Challan Books printed by utilizing their own funds and challan the Violators.
