SCREENING TEST NOTICE AND INTERVIEW NOTICE



As approved by the Chairman District Health Society (District Development Commissioner) Udhampur, it is informed that after perusal of the Application Forms received for the posts of Jr. Staff Nurses and FMPHW/MMPHW. It has come to fore that a total of 116 applications Forms were received against the 42 advertised posts of Jr. Staff Nurses and 15 Application Forms were received from Medical Block Panchari against one advertised post of FMPHW/MMPHW. Pertinent to mention here that out of 15 Application Forms, four of the candidates belongs to the same village i.e Latyar. In apropos of the above and taking into consideration the local selection criteria for the post of FMPHW/MMPHW mentioned in the advertisement No. 04 of 2019 dated 30-11-2019 listed at Sr. No. 14. It was unanimously decided by the constituted committee that the following four candidates (FMPHWs/MMPHWs) who belong to the same village are eligible for screening test as they fulfill the local selection criteria mentioned afore said.
