Subject: Micro Containment zone - Containment & Management of Corona Virus (COVID-19).

ORDER

Whereas, orders / circulars / instructions have been issued from time to time from this office with regard to the subject and reference cited above for checking the further transmission of virus and breaking of chain in spreading; and

Whereas, sixteen persons tested positive for Covid-19 within Two days therefore the area has become more vulnerable as far as further transmission of the COVID-19 is concerned; and

Whereas, it is necessitated to break further transmission of disease in the area and it becomes imperative to take stringent precautionary measures like declaring an area of village as Micro Containment Zone.

Now therefore, in view of the above, I, **Indu Kanwal Chib, KAS, District Magistrate Udhampur** by virtue of powers vested under the provisions of Section 144 CrPC, the National Disaster Management Act, 2005 and the Epidemic Diseases Act, 1897 do hereby order as follows: -

Micro Containment Zone:

1. 60 house hold in Village Baryal Mian Bagh (Dhangar) Udhampur.
2. Approximate area of 500M radius.

Restrictions/Arrangements:

1. That surrounding area of the Micro Containment / are declared as Buffer Zones.
2. There shall be no inward or outward movement of any person from these villages and people shall stay at their homes and there shall be complete lockdown.
3. That there shall be no vehicular movement on internal lanes or roads connecting this village.
4. Tehsildar / SHO / TSO concerned shall ensure supply of essential commodities as per laid down protocols.
5. All establishments shall remain closed.
6. It shall be mandatory for all the persons coming out in the area to wear masks.
7. Any person(s) / group(s) / institution(s) found violating the directions contained herein this order shall be booked under the provisions of relevant act / rules / law.
8. **Naib Tehsildar Roun (M. No 9419159370)** shall be Nodal Officer of Micro Containment Zone so declared.
9. **Sh. Dr. Anil Gupta (M. No 9086004172)** PHC Tikri shall be Nodal Officer of Health Department in the Micro Containment Zone so declared.
