All applications must be accompanied with the following documents:-


1. Court fee stamps of Rs. 25/- (twenty five) to be affixed in the prescribed application form.
2. (i). 3 (Three) copies of attested Pass – Port size photo of the individual applicant  
(ii). 3 (three) copies of attested Pass-Port size photo of the proprietor in case the application is in the name of a firm and  
(iii) 3 (three) copies of attested Pass-Port size photo of the secretary, if application is in the name of Cooperative Society/NGO/SHGs.
3. Bank Guarantee of Rs. 1 lakh and Rs. 2 lakhs for Tribal and Non-Tribal respectively, to be executed in the non-judicial stamp paper of Rs. 10/-. The validity of the Guarantee should be of a minimum period of 6 (six) months (The original Bank Guarantee and one duplicate copy to be submitted along with the application form).
4. Documentary proof, Counter-signature by Headman/Nokma, regarding possession of godown and to be confirmed by a spot enquiry to be conducted by an enquiry officer nominated by the Deputy Commissioner (Supply) Nongstoin.
5. Trading License for Non-Tribal and for Tribal if application is in the name of a firm/company.
6. Professional tax
7. Scheduled Caste/Tribe Certificate.
8. Preference will be given to applicants who also have Basic IT Hardware and Internet Connectivity to update the stock of Foodgrains online on a regular basis.
9. Application of Cooperative Society N.G.O's and S.H.G.s, if found capable to run the Dealership, may also be given preference.
10. Marital Status:- Married/Unmarried (if married, enclose marriage certificate)
11. Certificate from the Inspector, Metrological Department, Nongstoin.
12. Certificate from the Food Safety Officer o/o The Dist. Medical & Health Officer, Nongstoin. } for the existing applicants.
