The India Meteorological Department ,(IMD) has stated the following Weather Warning and Forecast in West Khasi Hills :-

29th June & 30th June 2021 : Heavy to Very Heavy Rainfall with Extremely Heavy Rainfall is very likely at isolated places

1st July 2021 : Heavy Rainfall is very likely at isolated places
