ORDER UNDER SECTION 144 CrPC

No.NDC.6/01/18/21/Pt.II/7, Dated, Nongstoin, the 2nd September, 2021

WHEREAS, in view of high transmissibility of this particular variant of the virus, it is deemed necessary to take urgent measures to prevent further spread of the COVID-19 virus, to avoid an overwhelming strain on the health system and to avoid the loss of precious lives,

Whereas, more exhaustive steps are required to be undertaken to effectively contain the virus through proper tracing and isolation of positive persons including returnees, to mobilize all resources and community support for vaccination which is the only way to protect the population at large, to build capacity on all fronts including confidence on home care & home management of mild cases and to impart proper awareness on preventive aspects of the disease for which the Health Department has a critical window period,

Therefore, I, Shri T. Lyngwa, IAS, District Magistrate, West Khasi Hills District, Nongstoin in exercise of the power conferred upon me under Section 144 Cr.P.C read with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby promulgate **NIGHT CURFEW w.e.f 6th September, 2021 (Monday) to 13th September, 2021 (Monday) from 9:00 PM to 5:00 AM in West Khasi Hills District.**

1. No vehicular movement is permitted except for essential services including Health Services during the period of Night Curfew.
2. Inter- district or Intra-district movement of persons from and to West Khasi Hills District shall continue to be restricted except for those who fall under exempted category below. For any other travel of an essential or emergent nature permission shall be given by the Undersigned.
3. All major markets in West Khasi Hills District shall remain closed during the period of Night Curfew.
4. Inter-State movement of persons shall continue to be restricted. This shall not apply for transit vehicles of Assam/Tripura/Manipur/Mizoram.
5. Movement of Vehicles both Private and Commercial during Night Curfew are not allowed without obtaining permission from the authority.
6. Ecommerce activities, home delivery services, hardware stores and courier services are permitted only after obtaining permission from the Undersigned.
7. Opening of commercial establishments/shops/ malls and other non –essential activities on need basis are allowed to open as per the arrangement made by the Local Dorbar Shnongs or the Covid-19 Market Management Committee after proper consultation with the Incident Commander.
8. Religious places / places of worship are permitted to re-open in the District subject to compliance with the SOP issued by the Home (Political) Department vide Order No.POL.75/2020/Pt.I/108, dated 13.08.2021. Solemnization of marriages in religious places/places of worship shall be as per the aforementioned SOP.
9. Schools & Colleges are permitted to re-open in the District subject with effect from 1st September, 2021 vide Order No.POL.75/2020/Pt.I/112, dated 27.08.2021 issued by the Home (Political) Department to compliance with the SOP being issued by the Education Department.
10. Central and State Government Offices may function at 100% strength and shall close at 5.00 PM daily.

11. Banks and Post Offices may function at 100% strength and shall close at 5.00 PM daily.
12. Tourism for local, domestic and International Tourist are permitted to re-open in the District to compliance with the SOP being issued by the Tourism Department.
13. Restaurants and bars at Maximum 50 % are permitted as per Health Protocol for markets.
14. Funeral gatherings are restricted to 20 persons with prior permission from the Undersigned and there will be no procession to the Cemetery or Crematorium.
15. Movement of both Private and Commercial vehicles are allowed in Odd/Even number. No Private or Commercial vehicles are allowed to ply during the period of Night Curfew without obtaining permission from the Undersigned.
16. Limited construction activities are permitted only after obtaining permission from the Undersigned.
17. Movement of skilled manpower for construction/ activities are permitted only after obtaining permission from the Undersigned.
18. All employees of Government and private offices are advised to get themselves vaccinated.
19. Non- Contact Sports are permitted subject to prior permission from the undersigned.
20. Gymnasiums/ Yoga Institutes/ Fitness Centres are permitted to re-open subject to prior permission from the undersigned.
21. Engagement/Marriages ceremonies outside religious places / places of worship are restricted to a total of 20 persons with prior permission from the undersigned.
22. Wedding reception is not permitted.
23. Inter District movement is permitted. However movement of commercial vehicles into East Khasi Hills District shall be regulated by the Deputy Commissioner, East Khasi Hills District.

This Order will NOT apply to:-

1. Medical Team on duty/ Health services including Vaccination drive.
2. Essential services including Health Services, Food Corporation of India, Fire and Emergencies Services.
3. Movement of essential goods.
4. Press, Print and Electronic Media
5. Farming activities in rural areas including betel nut and betel leaf.
6. MGNREGA activities in rural areas.
7. Officers and staff of Corona Care Centre.
8. All officials on COVID-19 Duty.
9. Pharmacies, Police, Civil Defense and Home Guards.
10. Petrol Pumps, Electricity, Water Supply, Public distribution system.
11. LPG Deliveries, Telecommunication services/BSNL/Bharat Broadband Nigam Ltd/ CSCs.
12. NARI/1917i Teams
13. Public Works Department (PWD)/NHIDCL
14. Public Health Department (PHE)
15. Activities / services permitted by competent authority.
16. Solid Liquid Resource Management Volunteers.
17. Essential Veterinary services including feed and fodder movement for livestock for farmers.

The above mentioned services shall strictly comply with all protocols and SOPs including social distancing, proper wearing of mask, limiting of field staff to the barest minimum and other advisories of Government in the Health and Family Welfare Department **WITHOUT FAIL**.

Also, movement of vehicles carrying Essential good, Security Forces, Medical Equipment's and shops for repairs of trucks on highways are exempted. However drivers and attendants of the vehicles shall be subjected to medical screening as per laid down protocols.

Essential commodities will be made available through shops in the localities as per the arrangement made by the Local Dorbar Shnong under the Supervision of the Incident Commander. During the period of Night Curfew, citizens are instructed to restrict themselves within their respective homes and localities.

- * Vehicles are allowed to ply on ODD/EVEN Basis from 5.00 AM to 9.00 PM except during Night Curfew.
- * Political, Social, Public gathering including meetings, trainings and conferences are not permitted.
- * All shops/ establishments/ local taxis/ auto-rickshaws/ maxi cabs and buses should display prominently at a conspicuous place a sign of "Vaccinated" "Not Vaccinated" as per order memo No.COVID-19/MED-17/2021/289, dtd. 24/6/2021.

In view of the urgency of the matter this order has been made ex-parte.
