**ORDER**

No. COVID.19/Genl-35/2020/Pt.I/213, - In partial modification to this office Order No. COVID.19/Genl-35/2020/Pt.I/212, Dated 28<sup>th</sup> October, 2021 in the interest of regulating movement within the District and ease of enforcing strict SOP issued by the Government, the following arrangement of vehicular movement is made for West Khasi Hills District w.e.f 8<sup>th</sup> November, 2021 between 5:00 AM to 9:00 PM and until further orders as follows:

- I. Private Transport is permitted @100% except during Night curfew hours.  
II. Public Transport plying within the District, i.e. Buses, Local Taxi, Auto Rickshaw etc are permitted in Odd/Even System as below:-

<u>DAYS</u>	<u>ODD/EVEN</u>
Monday, Wednesday & Friday	0, 2, 4, 6 & 8
Tuesday, Thursday & Saturday	1, 3, 5, 7 & 9


- III. Inter- District commercial vehicles (Tourist Permit) are permitted @50% per day as per following arrangement:

<u>DAYS</u>	<u>NUMBER ENDING WITH</u>
Monday, Wednesday & Friday	0, 2, 4, 6 & 8
Tuesday, Thursday & Saturday	1, 3, 5, 7 & 9

<u>PUBLIC TRANSPORT</u>	<u>SEATING CAPACITY</u>
Bus, Minibus	50% or not more than 2+16
Local Taxi	1+3
Auto Rickshaw	1+2
5 seater	1+3
7 seater	1+5
11 seater	1+7

- IV. Vaccination status should clearly be displayed on the vehicle as per this office order No.COVID.19/MED-17/2021/290-A, Dated 24<sup>th</sup> June, 2021.  
V. Wearing of double mask or N-95 is mandatory for all persons (passengers), even for a single person driving a vehicle including private vehicles. Use of sanitizers is also mandatory and proper ventilation of the vehicles is advisable.  
VI. All Public Transport Authorities shall strictly enforced Covid-19 appropriate behavior and seating capacity inside the vehicles.

**Violation of any norms and advisories issued by the Government, Health & Family Welfare Department and this office will be liable for action as per Law by the appropriate authority.**
