**Para: 1** Applications are invited from eligible candidates from 01-08-2021 to 04-08-2021 in the prescribed "Application Format" for engaging the (20) ANM/MPHA (F) services on contractual/Outsourcing basis.

**Para: 3 Age:**

1	(18) Years	(34) Years	Age is reckoned as on 01.07.2021

The following relaxations allowed for reckoned the maximum age limits as per rules:

- i. For SC, ST&BCs – (05) years
- ii. For ex- service men – (03) years in addition to the length of service in armed forces.
- iii. Disable persons – (10) years.

**Para: - 4 Educational Qualification**

1. SSC
  2. (18) months MPHWH (F) Training Certificate recognized by the Telangana State Nursing and Midwives Council
- (Or)

(02) years Intermediate Vocational MPHWH (F) Course and have completed one Year Clinical training in selected Government Hospital in which these students have been permitted to undergo Clinical training.

**Para: 5 Method of Recruitment**

Recruitment shall be done as per the reference 1<sup>st</sup> cited above by the District selection Committee under the Chairmanship of Honorable District collector, Mancherial, the selection Committee consist of the following members:

1) District Collector, Mancherial	:	Chairman
2) Medical Superintendent, District Hospital, Mancherial	;	Member
3) Dy. Director, Social Welfare Dept	:	Member
4) DM&HO, Mancherial	:	Member & Convener

**Para: 6 Selection will be done based on the following criteria:**

- a) Recruitment will be done made by awarding marks obtain in qualifying examination (exclude the languages)
- b) Provisional list will be prepared based on the receiving of the applications and displayed in District official Website and DM&HO office Notice board for any objections. After objection period no requests will be considered. The same has been rejected.

**Para: 7 Rule of Reservation:**

- (i) Rule of Reservations in respect of Community, Disability, Ex-Service Men/Women shall be strictly observed as ordered by the Government of Telangana from time to time.

- (ii) The Rule of Reservations to local candidates is applicable as per the Presidential order.
- (iii) The districts should continue the existing Roster.

**Para: 8 Local Cadre**

The Candidates who have studied from 4<sup>th</sup> Class to 10<sup>th</sup> Class within the Mancherial /Erstwhile District will be determined as local candidate for the post of ANM/MPHA (F). the Candidate who claim in as local candidate, she should produce the Study Certificate from Class 4<sup>th</sup> to 10<sup>th</sup> SSC within the Mancherial /Erstwhile District, residence Certificate for not less than Seven (7) years to and Inclusive of the One Year Only.

For those candidates who have not studied in any education institutions as the case may be. Residence certificate will not be accepted. If a candidate has studied in any educational institution up to SSC or its equivalent.

**Para: 9 How to Apply**

- (ii) Filled in application form shall be submitted in person or through registered post to the O/o District Medical & Health Officer, Mancherial district. Applications which are received after due dates will be summarily rejected. District Selection Committee is not responsible for post delays.
- iii) Self-attested copies of the following Certificates should be enclosed along with the application form
- iv) Attested Copies of the following applicants should be enclosed along with the application Forms, should be orderly.

1	SSC or equivalent marks memorandum
2	Marks Memo's of qualifying examination i.e., (18) Months MPHW (F) Training Certificate recognized by the Telangana State Nursing and Midwives Council (or) Two intermediate Vocational MPHW (F) Course and have completed One year Clinical training in selected Govt. Hospital in which these students have been permitted to undergo Clinical training.
3	Registration Certificate of respective Councils/Board
4	Latest Caste Certificate Issued by the Thahasildar Concern
5	Study Certificate From 4 <sup>th</sup> to 10 <sup>th</sup> Class/ Residence Certificate in case of Private Study
6	Pass Post size Photograph duly pasted on the application form

**Rs. 300/-** application registration fees to be paid in form of DD in favour of District Medical and Health Officer, Mancherial at the time of registration of application.

Application containing wrong claims relating to basic qualifications/ eligibility/ Age/Education qualification/and other basic eligibility criteria will be liable for rejection.

The District selection committee will not be responsible for any consequences arising out of furnishing of incorrect and incomplete details (or) Omissions in the Application Forms.

The O/o DM&HO Mancherial will not be responsible for delay receipt/ Non receipt of applications.

Candidates belongs to SC, ST, BC category should enclose a copy of the caste certificate issued by the Competent authority (Govt. of Telangana) at the time of applications only, later submissions not acceptable. Hence candidate should attend in person along with all original certificates at the time of verification.

Any attempts by the candidates either directly or indirectly to influence the selection committee or other authorities will disqualify the candidature for the post.
