
1. **Minimum Height** : 165 cm for Male and 150 cm for Female

3. **Upper Age Limit** : 50 Years for Male and 47 Years for Female at the time of Callout duty as Marshal
4. **Medical Certificate** : the candidate should be physically fit and should get a certificate to this effect from any Doctor of Government Hospital/Dispensary or MBBS Doctor.
5. Must be enrolled & active Civil Defence Volunteer on or before 15.03.2020.
6. Must have completed Civil Defence Basic Training.
7. Must have Valid Aadhaar Card.
8. Must have Valid Bank Account in Delhi.

Sub-Division Alipur & Sub- Division Narela will be report at Nehru Yuva Kendra Ground, Alipur.


Sub-Division Model Town will be report at Shaheedi Smarak, Opposite Swami Sharaddhanad College, Alipur.
