6. No Loan Certificate under Self Employment Scheme from District Industries Centre and Employment & Counseling Centre concerned.

The appointee shall report to Chief Controller Finance, LAHDC, Kargil alongwith relevant Certificates in original **within 15 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled.**

If on verification, even on a later stage, it is found that the Certificates produced by the appointee are proved fake or forged, **the appointment shall be cancelled abinitio.**
