Subject: Selection list for the post of Jr. Assistant in various departments.

Whereas vide advertisement Notice No: 01 of 2016 Dated: 16.01.2016 and Item No: 01, (96) posts of Junior Assistants was advertised with the category wise breakup contained in the said notifications.

Whereas after withdrawal of some posts by some of the departments subsequent to the above mentioned advertisement, the clear vacancy available at present is 66 posts.

Whereas the written test of the candidates who had qualified the typing tests held earlier for the 66 posts was conducted on 28.12.2018 in Indoor Stadium Kargil. At Question No: (34) of the question paper, all the four options of answer were meant for an older version of the software in question, but the same was not mentioned there inadvertently; and, therefore, in order to maintain impartiality, the one mark/point of the same question/answer shall be awarded to all the candidates appearing in the written test.

Whereas in order to shortlist the candidates after the typing tests and the written tests, the following criteria were adopted:

- For the overall selection process: Equal weight-age to both typing and the written tests with 40 points each
- For the Typing Test: Equal weight-age (50%) to both speed and accuracy with the following formula
 - Maximum Marks for Accuracy = 100
 - Maximum Marks for Speed = 56 (that is the maximum marks obtained for speed in the typing tests by any candidate)
 - *since there is no maximum limit for typing speed, above criterion of relative percentage has been adopted.*
 - Formula for Typing Marks out of 40 =
 $\{(Accuracy/Max Marks for Accuracy) \times 0.5 + (Speed/Max Marks for Typing) \times 0.5\} \times 40$

Now, therefore, on the basis of above criteria or conditions of eligibility and on the basis of performance by the candidates in the written test and the type test, the select list of the candidates is hereby published as Annexure "A" to this notification.

Whereas the candidates appointed against the posts should be governed by the Jammu and Kashmir Recruitment Rule issued vide SRO-202 of 2015, as already mentioned in the advertisement Notice.

The selected candidates are directed to report to the concerned Head of the Departments or the requisitioning authority along with the following original certificates for verification within 21 days from the date of publication of this selection list:

- I. Academic/Technical Qualification (Diploma certificate)
- II. Date of Birth Certificate (Matriculation)
- III. Permanent Resident Certificate issued by competent authority.
- IV. Certificate from the concerned authority to the effect that no loan under Self Employment Scheme has been taken by the selectee.
- V. Reserved Category Certificate issued by the competent authority.
- VI. Character Certificate

1. The indenting department shall verify the genuineness of all the above certificates or any other necessary document before appointing the candidates against the vacancies.
2. In case it is found that any candidate was selected on the basis of false documents or by misrepresenting the facts, his/her selection as such shall be deemed to have been cancelled and will be dealt under Law of the land.
3. In case, if on verification, the certificates produced by the selectees are proved fake or forged, the selection shall be cancelled abinitio.
4. The candidate who fails to produce the authenticity of certificates / testimonials within the prescribed period as may be asked by the competent authority may forfeit their candidature without any further notice.
5. The selection of the candidates will be subject to the outcome of the writ petition, if any, pending in the competent court of law.
