

Minutes of the meeting of District Rate Contract Committee, Kargil for finalization of rate contract for purchase of hard coke required for various departments for the year 2019-20

A meeting of District Rate Contract Committee was held today on 30.09.2019 to finalize the rate contract of **Hard coke (A grade, free from moisture,dust,frost)**, required for various departments for the year 2019-20. The meeting was presided over by the Deputy Commissioner/CEC, LAHDC, Kargil (Chairman). The Following officers attended the meeting:

E-Tender for purchase of **hard coke** required for various departments for the year 2019-20 was invited by the Deputy Commissioner Kargil (Chairman Distt. Rate Contract Committee Kargil) vide NIT No. 18-DCK of 2019, dated 30.08.2019 with the last date for online submission of bids up to 13.09.2019 2:00 pm. Up to the last date for receipt of hard copies, 06 tenderers received. The technical bids were opened on 14.09.2019, and 05 tenderers qualified for opening of online financial bids (BOQ).

The online financial bids (BOQ) were opened on the 23.09.2019 by the tender opening committee. The comparative statement was downloaded and signed by the committee and put up before the contract Committee for finalization of rate contract for the year 2019-20.

The Committee after thorough discussion and deliberations decided to approve the rate of following item for the current financial year 2019-20 in favor of the L1 bidder:

It was also decided in the meeting that intending departments shall place supply order for the approved Items on the approved rates within the sanctioned budget grant for the current financial year 2019-20 after observing all codal formalities as required under rules and to ensure the receipt of the materials as per proper specification and quality standards well in time after getting them verified by the verification committee which will be constituted later on.

The rate contract shall remain valid for one year from the date of issuance of this rate contract or till next rate contract is approved whichever is earlier. The approved suppliers shall have to complete the whole supply up to ending October, 2019.


