NOTIFICATION

Pre-matric/Post-matric/Merit-cum-Means Scholarships for the students belonging to the six Centrally notified Minority Communities viz Buddhist, Christian, Muslim, Sikh, Jain and Zoroastrian (Parsis) are awarded to the students pursuing studies in India in a Government or recognized Private School/Institute/College/University form the notified minority communities who have secured **not less than 50% marks** or equivalent grade in the previous final examination and the annual income of whose parents/guardians **from all sources do not exceed Rs. 1.00 Lakh for Pre-Matric, Rs. 2.00 Lacs for Post-Matric & Rs. 2.50 lacs for Merit-cum-Means Scholarship.**

During 2020-21, The online implementation of the Pre-Matric, Post-Matric and Merit-cum-Means based Scholarship Schemes will be done through the National Scholarship Portal(NSP) of the Government of India, under URL www.scholarships.gov.in, A Mobile-National Scholarships (NSP) has also been prepared for the same for use by applicants in the remote/hilly areas. A link to the site is also made available in the website of the Ministry i.e. www.minorityvaffairs.gov.in. Only **Online application under the schemes (Pre-Matric/Post-Matric/Merit-cum-Means ScholarshipS) will be accepted and no request for Offline application will be entertained. It may be noted that submission of Aadhaar is mandatory.**


The above scholarships are subject to following terms and conditions:

1. The scholarships admissible to only two from a family/guardians and students should be regular in attendance for which the yardstick shall be decided by the competent authority.

2. A student shall be eligible for only one scholarship out of available scholarships of central Government meant for SC/ST/OBC/Minority.
3. The course being pursued should be of minimum one year duration.
4. Applicants are required to apply online against any one of the scholarship schemes as per his/her eligibility.
