2. In case on verification, it is found that the candidate was selected on the basis of false/forged documents misrepresenting the facts, his selection as such shall be deemed to have been cancelled and will be dealt under Law of the land.
3. The candidates who fail to produce the authenticity of certificates / testimonials within a prescribed period as may be asked by the competent authority will forfeit their candidature without any further notice.
4. The selection of the candidates will be subject to the outcome of the writ petition, if any, in the court of law.

Note: While due care has been taken in preparing the result, DSSRB reserves the right to rectify errors and omissions, if any detected at any stage.


